



Erie County Sheriffs Office Media Release Summary

The Erie County Sheriff's Office responded to 179 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
5/3	Love Rd.	Suspicious Incident	The complainant states that an unknown person was knocking on his door during the late hours of the night. Deputies checked the area but were unable to locate any persons.
5/3	Grand Island Blvd.	Suspicious Person	The complainant states that a male subject ran out into the street and the complainant almost struck him. Deputies located the intoxicated male subject and advised him.
5/3	Grand Island Blvd.	Suspicious Person	Deputies located a male subject stumbling down the roadway. The subject was advised and assisted home.
5/3	East River Rd.	Animal Loose	The complainant states a dog was wandering through the neighborhood and appeared to be lost. The Dog Control Officer was notified.
5/3	Schwegler Rd.	Youth Activity	The complainant states that several youths in the area were knocking down signs and causing trouble. Deputies checked the area but were unable to locate any subjects by the description given.
5/3	East River Rd.	Youth Activity	The complainant states that a youth was shooting squirrels with a BB gun. Deputies checked the area but were unable to locate any youths by the description given.

Traffic Arrest	Following a traffic stop, Deputies arrested 28 y/o Andrew Manning of Tonawanda for Aggravated Unlicensed Operation 2 nd Degree (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently revoked. Manning was issued an appearance ticket returnable to the Town of Grand Island Court.
5/3	Grand Island Blvd.	Reckless Operation	The complainant states a vehicle was traveling on the wrong side of the road and then pulled into a motel. Deputies located the driver and advised her.
5/3	Love Rd.	Youth Activity	The complainant states a vehicle was driving around in the Kaegabine School parking lot during the late evening hours. Deputies checked the area but were unable to locate the vehicle by the description given.

5/3	Grand Island Blvd.	Suspicious Vehicle	Deputies located several vehicles parked in the Fantasy Island parking lot during the late hours of the night. Deputies determined the vehicles belonged to employees of the park on site rehearsing for upcoming shows.
5/3	West Park Rd.	Trespass	Deputies observed a subject going through the front yards of numerous residences and looking into mailboxes. When approached by Patrol, the subject attempted to flee and was found in a nearby yard. Deputies investigation led to the arrest of 23 y/o Scott Matheis of Grand Island for Trespass (Violation), Disorderly Conduct (Violation) and Obstruction of Governmental Administration 2 nd Degree (Class A Misdemeanor). Matheis was issued an appearance ticket returnable to the Town of Grand Island Court.
5/4	Town Hall Te.	Criminal Mischief	The complainant states that sometime during the night, an unknown person(s) damaged his vehicle.
5/4	Marlin Rd.	Animal Complaint	The complainant states his neighbor's dog was being aggressive and ran at the complainant. The Dog Control Officer was notified.
5/4	Long Rd.	Reckless Operation	The complainant states that the driver of another vehicle cut him off and was swerving all over the roadway. The complainant followed the vehicle until it was parked at Tops. Patrol located the driver and advised him.
5/4	Royal Oak Cr.	Criminal Mischief	The complainant states sometime in recent days, an unknown person(s) broke the window to her vehicle. Nothing was reported missing.
5/5	Whitehaven Rd.	Suspicious Vehicle	The complainant states that a vehicle was stopping in traffic and looking into garbage containers. Deputies checked the area but were unable to locate the vehicle by the description given.
5/5	First St.	Suspicious Vehicle	The complainant states that a suspicious vehicle was repeatedly driving down the street and then the driver yelled at the complainant. Deputies checked the area but were unable to locate the vehicle by the description given.
5/5	Dolphin Dr.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke with the occupants and determined the call to be a misdial.
5/5	Ransom Rd.	Larceny	The complainant states that sometime in the last hour, his daughter's jacket and cell phone were stolen by an unknown person(s). The complainant notified Patrol on a later date that the items were recovered and confirmed they were not stolen.
5/5	West River Pkwy.	Suspicious Vehicle	The complainant states that two vehicles were parked next to each other on the grass shoulder of the roadway and thought it looked strange. The vehicles left prior to the arrival of Patrol. Deputies checked the area but were unable to locate the vehicles by the descriptions given.

5/8	Baseline Rd.	Marijuana Possession	Following a traffic stop, Deputies arrested 20 y/o Andrew Gugino of Grand Island for Unlawful Possession of Marijuana (Violation) and several traffic infractions. Gugino was issued an appearance ticket returnable to the Town of Grand Island Court.
5/8	Love Rd.	Warrant Arrest	Following a traffic stop, Deputies arrested 41 y/o Lori Smith of Grand Island after a check showed she had an outstanding Bench Warrant from the Town of Grand Island Court. Smith was transported to the Erie County Holding Center.
5/8	Laurie La.	Larceny	The complainant states that a known person(s) was making fraudulent purchases using his credit card. Investigation Ongoing.
5/9	Grand Island Blvd.	Suspicious Person	Deputies located a female subject sitting inside the traffic circle during the late hours of the night. The female was advised and left without incident.
5/9	Whitehaven Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke with the occupants and determined the call to be a misdial.
5/9	North Colony Rd.	Suspicious Incident	The complainant states that sometime during the night an unknown person(s) knocked over his mailbox. No damage was observed to the mailbox.
5/9	Alvin Rd.	Unauthorized Use of a Motor Vehicle	The manager of Fucillo Chevrolet states that sometime in recent years an unknown person(s) stole a vehicle from the sales lot.
5/9	Center Terr.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke with the occupants and determined the call to be a misdial.

5/9	Ransom Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
5/9	Continental La.	Larceny	The complainant states sometime in recent nights, an unknown person(s) stole various items from his unlocked vehicle.
5/9	First St.	Larceny	The complainant states that sometime in recent days an unknown person(s) stole the license plate off her vehicle.
5/9	West Niagara River	Suspicious Incident	Deputies located an unmanned kayak in the river. The Coast Guard was notified.
