



## Erie County Sheriff's Office Media Release Summary

The Erie County Sheriff's Office responded to 357 calls the week of this report. Below is a sampling of the noteworthy incidents in **Grand Island**.

05/03	Disturbance - Other	Grand Island Blvd.	Deputies received a report of a disturbance in progress. Deputies interviewed the involved parties and discovered that one party did not want the other party at their home. No criminal charges. The party was given a courtesy ride to Buffalo.
05/03	UUMV	Staley Rd.	Deputies received a report from a complainant the reported their vehicle taken overnight. Initial investigation and report completed and referred to detectives for further investigation.
05/04	Traffic Stop	West River Rd.	Deputies initiated a traffic stop off a vehicle for observed traffic infractions. The driver was found to have a suspended license. Subject arrested and processed and issued tickets and released to a third party.
05/05	Shots Fired	Fix Rd.	Deputies received several calls of gunshots and speeding vehicles in the area of Fix and N. Colony Rd. Deputies reported that a vehicle was chasing, and an occupant was shooting at another vehicle. Some of the rounds hit a house in the area. Deputies, Grand Island Police, State Police as well as the Erie County Sheriff's Office QRF (a quick responding subsection of ECSO S.W.A.T.) Air One, the Erie County Sheriff's Office helicopter was put on alert. Several members of the Erie County Sheriff's Office Detective Bureau also saturated the area in unmarked vehicles. No one appears to have been injured during the incident. Detectives continue to investigate.
05/06	Suspicious Person/Vehicle	W. Oakfield Rd.	Deputies received a call that the subject was hunched over in a vehicle. Deputies located and interviewed the subject who explained that they were surveilling their significant other like a private investigator and must have fallen asleep.
05/07	Customer Trouble	Grand Island Bd.	Deputies were contacted by an employee of a business who reported a customer was on their way in and that they expressed that they were not happy with the business. Patrol assisted with the transaction without incident.

05/07	Disturbance-Other	Redway Rd.	Deputies were called to a verbal argument in the road. Patrol spoke with the caller who stated a vehicle with two occupants were yelling and arguing with them from the road. Caller told them the police were on the way and they left. A search of the area returned negative results for the suspect vehicle.
05/08	Disturbance-Other	Whitehaven Rd.	Deputies responded to a report of two subjects having a verbal altercation. Subjects separated and one was given a courtesy ride to another location. Nothing criminal in nature.
