The Erie County Sheriff's Office responded to 158 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

5/10	Baseline Rd.	Reckless Operation	The complainant states a vehicle was driving all over the roadway. Deputies found the vehicle in a nearby apartment complex but were unable to locate the driver.
5/10	Grand Island Blvd.	Criminal Mischief	The complainant states that sometime during the night, an unknown person(s) slashed his tires.
5/10	N. Colony Rd.	Neighbor Dispute	The complainant states a neighbor was on his property trimming a tree without permission. All parties were advised.

5/11	Marjorie Dr.	Suspicious Incident	The complainant states that sometime during the night, an unknown person(s) egged his vehicle. No damage was reported.
5/11	Ransom Rd.	Residential Burglary	The complainant states that sometime during the day, an unknown person(s) entered her unlocked apartment and stole various items from inside. Investigation Ongoing.
5/11	Stony Point Rd.	Suspicious Incident	The complainant states that sometime during the day, an unknown person(s) cut down several limbs of a tree on his property.
5/12	Love Rd.	Suspicious Incident	The complainant states that a naked male subject was sleeping in a vehicle in a parking lot. Deputies checked the area and determined the complaint to be unfounded.
5/12	Whitehaven Rd.	Suspicious Incident	The complainant states that he found a bottle of

			prescription pills outside of NOCO. Deputies took custody of the pills and destroyed them.
5/12	Grand Island Blvd.	Burglary	Employees of Advance Auto Parts state that sometime during the night, an unknown person(s) used a code to deactivate the alarm after entering the building and while inside stole an undetermined amount of money. Investigation Ongoing.
5/12	Grand Island Blvd.	Wires Down	Deputies responded to a report of wires down in a parking lot of a business.
5/12	Jamestown Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
5/12	Whitetail Run	Suspicious Incident	The complainant states that she paid for an item on Ebay and never received it. The complainant was advised to contact Ebay to report the possible fraud.
5/12	Forest Creek La.	Youth Activity	The complainant states several youths were operating a golf cart in the street. Deputies located the youths and advised them.
5/13	Fix Rd.	Reckless Operation	The complainant states that a motorcycle was racing down the street, and that the issue was an ongoing problem. Deputies checked the area but were unable to locate the vehicle.
5/14	Windham La.	Animal Complaint	The complainant states that a neighbor's dog jumped through her screen window. The Dog Control Officer was notified.
5/14	Oak Harbor Rd.	Alarm Ringing/Open Door	Deputies responded to a report of a Burglary Alarm and upon arrival they found an open door to the residence. Deputies searched the house but found no persons inside.
5/14	Love Rd.	Reckless Operation	The complainant states that a green colored Camaro cut her off and was speeding down the street. Deputies checked the area but were unable to locate the vehicle by the description given.
5/14	Grand Island Blvd	Reckless Operation	The complainant states that a motorcycle was speeding and swerving all over the roadway. Deputies located the motorcycle nearby and advised the driver.
5/14	Stony Point Rd.	Residential Burglary	The complainant states that sometime in recent hours, an unknown person(s) kicked in her garage door which caused the alarm to activate. Deputies determined that no entry to the residence was made.
5/14	Grand Island Blvd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
5/15	Whitehaven Rd.	Property Found	A complainant found a set of keys and turned them into Deputies at the Grand Island Substation. The owner was contacted and the keys were returned.
5/16	Deerwood La.	Suspicious Person with Vehicle	The complainant states that a suspicious vehicle was parked in front of his residence. Deputies located the vehicle and determined the subjects inside were on location looking to buy a nearby house.
5/16	Grand Island Blvd.	Suspicious Person	Employees of McDonald's state that an intoxicated male subject came into the store looking for an unknown female. The male subject left in an unknown direction prior to the arrival of Patrol. Deputies checked the area but were unable to locate the subject by the description given.
