The Erie County Sheriff's Office responded to 165 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
5/11	West River Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
5/11	Bedell Rd.	Criminal Mischief/Assault	Complainant states that an intoxicated male subject entered his apartment during the early hours of the morning. When the complainant confronted him the subject began to assault the complainant causing him minor injuries. The subject then fled the apartment. Deputies' investigation led to the arrest of 22 y/o Derek Lorenzo of Grand Island for Assault 3 rd Degree (Class A Misdemeanor) and Criminal Mischief 4 th Degree (Class A Misdemeanor). Lorenzo was issued an appearance ticket returnable to the Town of Grand Island Court.
5/11	White Tail Run	Pistol Permit Investigation	Deputies conducted a background check of an individual who applied for a pistol permit.
5/11	Stony Point Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
5/11	Beaver Island State Park	Suspicious Incident	Complainant states that a male subject was driving through the park in his vehicle and appeared to be consuming alcohol. Deputies located the vehicle in question and spoke to the driver. No alcohol was observed inside of the vehicle and the driver was advised.
5/11	West Oakfield Rd.	Parking Complaint	Complainant states that several vehicles were parked illegally on the street. Deputies checked and determined the complaint to be unfounded.

5/11	Huth Rd.	Youth Activity	Complainant states that several youths were playing on gym equipment that was mistakenly left outside of Huth Elementary School. Deputies located the equipment but the youths left prior to the arrival of Patrol.

			area and determined the complaint to be unfounded.
5/12	East River Rd.	Customer Trouble	An employee of a cab company stated that his fare kept driving him around in circles. Deputies advised both parties and the fare was paid with no further incident.
5/12	Whitehaven Rd.	Accident Hit & Run	Complainant states that a vehicle was driving on the road with heavy front end damage. The complainant followed the vehicle to Holiday Inn. The vehicle in question was later found to have damaged an electric pole and another vehicle. Deputies located the vehicle with no driver around. As the Tow Company was hooking up the vehicle, a man came out of the Hotel and claimed to be the driver. Deputies issued the man 11 traffic tickets returnable to the Town of Grand Island Court.

5/12	Bedell Rd.	Suspicious Incident	Complainant states that she smelled marijuana coming from the hallway of her apartment building. Deputies checked and determined the complaint to be unfounded.
5/13	Grand Island Blvd.	Accident Hit & Run	Complainant states that while she was in Tops, a vehicle struck her parked car and caused minor damage.
5/14	Fix Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke to the occupants and determined the call to be a mistake.
5/14	Grand Island Blvd.	Suspicious Incident	Employee at Tops Express states that a customer told her to call 911 because he needed a safe house. Deputies located the subject and advised him.
5/14	Ransom Rd.	Unauthorized Use of a Motor Vehicle	Complainant states that her vehicle had been stolen from the Grand Island High School parking lot. Deputies' investigation led to the arrest of a Juvenile Offender for Unauthorized Use of a Motor Vehicle 3 rd Degree (Class A Misdemeanor) and Grand Larceny 4 th Degree (Class E Felony). The Juvenile Offender was transported to the Erie County Holding Center pending his arraignment in the Town of Grand Island Court.
5/14	Alvin Rd.	Fraud	Employees at Fucillo Hyundai state that a subject tried to fill out a credit card application using the name of a deceased person. Investigation Ongoing.
5/14	Fix Rd.	Accident Injury	Deputies responded to a report of a 2 car motor vehicle accident. 3 subjects were transported to local hospitals with seemingly non-life threatening injuries.
5/14	Bedell Rd.	Missing Person	Sheriff's Deputies along with an officer from the Kenmore Police Department located a teen that had been reported missing approximately 1 month earlier. The teen was found in good health and was turned over to the

			custody of the Kenmore Police Department.
5/15	Carl Rd.	Road Obstruction	Complainant states that a basketball net was lying in the roadway. Deputies removed the net.
5/15	Cardinal La.	ATV Operation	Complainant states that a dirt bike was riding up and down the street. Deputies located the dirt bike and advised the operator.
5/16	Havenwood La.	Youth Activity	Complainant states he could hear about a dozen kids playing loud music and yelling from somewhere on the street. Deputies checked and determined the complaint to be unfounded.
5/16	Stony Point Rd.	Suspicious Incident	Complainant states that a female driver appeared to be smoking marijuana while driving on Stony Point Rd. Deputies located the vehicle and spoke to the driver. The complaint was determined to be unfounded.
5/16	Alvin Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
5/16	Grand Island Blvd.	Attempted Break In	Complainant states that it appeared someone tried to break into some storage sheds from a local business. Nothing was reported missing and the attempt caused minor damage to the sheds. Investigation Ongoing.
5/16	West River Rd.	Suspicious Person	Complainant states that a male subject came to his door selling tickets for an inner city youth program. Deputies located the subject who had all the proper paperwork to solicit on Grand Island.
5/16	Fix Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke to the occupants and determined the call to be a mistake.
5/16	Bedell Rd.	Loud Music	Complainant states that a vehicle in the parking lot of his apartment complex was playing music loud during the late evening hours. Deputies located the vehicle and advised the driver.
5/17	Sandy Beach Rd.	Animal Loose	Complainant states that a dog was wandering the neighborhood. The Dog Control Officer was notified.
5/17	Grand Island Blvd.	Larceny	Complainant states that a co-worker stole a large amount of cash from his motel room sometime during the day. Investigation Ongoing.
5/17	Beaver Island State Park	Suspicious Person with Vehicle	Complainant states that a male subject in a vehicle was taking pictures of people in the park. Deputies located the subject and advised him. The subject left the park without any incident.
5/17	Woodstream Dr.	Reckless Operation	Complainant states that a vehicle was swerving all over the roadway. Deputies checked the area and located the vehicle parked and unoccupied at a nearby residence.
