The Erie County Sheriff's Office responded to 161 calls the week of this report. Below is a sampling of the noteworthy incidents on **<u>Grand Island</u>**.

			Misdemeanor) and Endangering the Welfare of A Child
			(Class A Misdemeanor). Schork was transported to the
			Erie County Holding Center in lieu of \$500 bail.

			accident. No injuries were reported.
