

## **Erie County Sheriffs Office Media Release Summary**

The Erie County Sheriff's Office responded to 155 calls the week of this report. Below is a sampling of the noteworthy incidents on **<u>Grand Island</u>**.

4/23	Grand Island Blvd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled near the intersection of Webb Rd.
4/23	Fix Rd.	Shots Fired	The complainant states a nearby neighbor was shooting a gun close to his residence. Deputies spoke with the neighbor and advised him.
4/23	Baseline Rd.	Exposure	The complainant states that while working out at Snap Fitness during the late hours of the night, she noticed a male subject loitering around the front of the business. After a few minutes the male subject pulling down his pants and began masturbating while watching her inside. The male subject fled just prior to the arrival of Patrol. Deputies located a male subject matching the description nearby but when Patrol approached him the subject fled on foot through the woods south of Tops. Deputies pursued but were unable to locate the male after a lengthy search.
4/24	West River Rd.	Animal Loose	The complainant states he dog was running loose in the neighborhood. The Dog Control Officer was notified.
4/25	West Oakfield Rd.	Accident Hit & Run	The complainant states that a vehicle drove over his lawn and took out his mailbox sometime during the night. Deputies located a vehicle nearby that fit the description from the motor vehicle parts left at the scene. Deputies made contact with the driver and issued several tickets.
4/25	Love Rd.	Suspicious Person	The complainant states that a male subject was standing underneath the pedestrian bridge and was worried because school was letting out soon. Deputies checked the area but were unable to locate the subject by the description given.
4/25	Sherman Dr.	Suspicious Person with Vehicle	The complainant states that a suspicious occupied vehicle was parked on the street for over an hour. Deputies located the vehicle parked legally and unoccupied.
4/26	Broadway	Youth Activity	The complainant states that several youths were walking down the street throwing garbage cans in the road during the late hours of the night. Deputies checked the area

			but were unable to locate the youths. Numerous garbage cans had to be removed from the roadway.
4/26	Grand Island Blvd.	Disorderly Person	An employee of Wave Lengths states that a male subject came into the store and stated that he walked from Niagara Falls. The male began consuming beer from the case he brought with him and was asked to leave. Deputies advised the male subject who left without incident.
4/26	Whitehaven Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call at Byblos Niagara Resort & Spa. Deputies spoke to the employees and determined the call to be a misdial.
4/26	The Commons	Larceny	The complainant states that sometime in recent days, an unknown person(s) stole prescription pills from his residence.
4/26	Love Rd.	Accident Hit & Run	The complainant states that a vehicle struck his mailbox and left the scene. Deputies checked the area but were unable to locate the vehicle involved.
4/27	Bedell Rd.	Noise Complaint	The complainant states a nearby neighbors TV was too loud during the late hours of the night. Deputies were unable to make contact with the neighbor.
4/27	Enola Rd.	Suspicious Incident	The complainant states that sometime during the night, an unknown person(s) egged her residence.
4/28	Love Rd.	Suspicious Incident	The complainant states for the last 2 days a subject in a vehicle was following him around. Deputies located the vehicle at the registered owners address after the complainant was able to provide a plate. The driver of the vehicle was advised.
4/28	Long Rd.	Burglary	Employees of the renovation company remodeling the Dunlop Building state that sometime in recent days, an unknown person(s) broke into the premise and damaged numerous items while inside.
4/28	Whitehaven Rd.	Suspicious Person	Employees of Noco state that several subjects were inside of the garbage corral and did not have permission to be there. Deputies checked the area but were unable to locate the males by the description given. Nothing was reported stolen or damaged.
4/28	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
4/29	South State Pkwy.	Traffic Complaint	The complainant states that a vehicle was driving recklessly and cutting off other cars. Deputies checked the area but were unable to locate the vehicle by the description given.
4/29	Ransom Rd.	Larceny	The complainant states that her daughter's clothes and money were stolen by an unknown person(s) from a locker room at Grand Island High School.
4/29	Baseline Rd.	Suspicious Incident	The complainant states that a youth was breaking windows on a nearby vacant house. Deputies located the youth but it was determined the windows were broken prior to the youth being on the property.
4/29	Driftwood Dr.	Animal Loose	The complainant states that the neighbor's dog was running loose again and chased her friend. The Dog Control Officer was notified.
4/29	Grand Island Blvd.	Assault	The complainant states that he was punched numerous

times in the face by a known subject while at TC's Lounge. Deputies investigation led to the arrest of 28
y/o Daniel Gilbert of Grand Island for Assault 3 <sup>rd</sup> Degree
(Class A Misdemeanor) and Assault 2 <sup>nd</sup> Degree (Class E
Felony). Gilbert was transported to the Erie County
Holding Center pending his arraignment in the Town of
Grand Island Court.
