

Erie County Sheriffs Office Media Release Summary

The Erie County Sheriff's Office responded to 171 calls the week of this report. Below is a sampling of the noteworthy incidents on **<u>Grand Island</u>**.

4/27	Bedell Rd.	Narcotics Arrest/Marijuana Possession	 Following a traffic stop, Deputies arrested 21 y/o Korey Dimatteo and 22 y/o Edward Bolton both of Grand Island. Dimatteo is charged with Criminal Possession of a Controlled Substance 7th Degree (Class A Misdemeanor), 2 counts of Criminal Use of Drug Paraphernalia 2nd Degree (Class A Misdemeanor), Unlawful Possession of Marijuana (Violation) and Possession of a Controlled Substance Outside of Original Container (Violation). Bolton is charged with Unlawful Possession of Marijuana (Violation). Additional charges are pending against both subjects and each were issued appearance tickets returnable to the Town of Grand Island Court.
4/27	Grand Island Blvd.	Marijuana Possession	Following a traffic stop and subsequent investigation, Deputies arrested 22 y/o Justin Kopenski of Grand Island for Criminal Possession of Marijuana 5 th degree (Class B Misdemeanor), Tampering with Physical Evidence (Class E Felony) and Unlawfully Growing Cannabis (Class A Misdemeanor). Kopenski was arraigned in the Town of Grand Island Court and posted \$500 bail.

5/5			filling a soda bottle with common household items
			which then cause a chemical reaction to take place and
			build pressure inside of the bottle. Although seemingly
			small, these bottles can cause harm by the rapid release
			of pressure and have been known to cause chemical type
			of pressure and have been known to cause chemical type

		burns due to the ingredients used. The Erie County Sheriffs Office advises residents to call 911 immediately if they come across any of these items that contain suspicious looking liquids and do not handle them.

Deputies responded to 12 Burglary False alarm calls during the dates of this report
