The Erie County Sheriff's Office responded to 227 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

| 6/4 | Crescent Rd. | Suspicious Person with Vehicle | The complainant states that a dark colored SUV was parked in the street and the teenagers inside were blasting music. Deputies checked the area but were unable to locate the vehicle by the description given. |

Following a traffic stop, Deputies arrested 56 y/o Tony Smith of Buffalo for Unlawful Possession of Marijuana (Violation) and traffic infractions. Smith was issued an appearance ticket returnable to the Town of Grand Island Court. |
| 6/5 | Love Rd. | Accident PDO | Deputies responded to a report of a 1 car motor vehicle accident in the parking lot of 7-11. No injuries were reported. |
| 6/5 | I-190 | Traffic Arrest | Following a traffic stop, Deputies arrested 40 y/o Michael Dinieri of Niagara Falls for Aggravated Unlicensed Operation 2 nd Degree (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently suspended. Dinieri was issued an appearance ticket returnable to the Town of Grand Island Court. |

Both Juvenile Offenders were issued an appearance ticket returnable to the Town of Grand Island Court. |

| 6/7 | Grand Island Blvd. | Traffic Arrest | Following a traffic stop, Deputies arrested 39 y/o Shennedoah Elkin of Grand Island for Aggravated Unlicensed Operation 3 rd Degree (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently suspended. Elkin was issued an appearance ticket returnable to the Town of Grand Island Court. |
| 6/7 | Whitehaven Rd. | Marijuana Possession | Following a traffic stop, Deputies arrested 18 y/o Travis Mikulski of Grand Island for Unlawful Possession of Marijuana (Violation) and a traffic infraction. Mikulski was issued an appearance ticket returnable to the Town of Grand Island Court. |

| 6/8 | I-190 | Warrant Arrest | Following a traffic stop, Deputies arrested 26 y/o Steven Law of Niagara Falls after a check showed he had an outstanding warrant from the Town of Niagara. Law was transferred to the custody of the Town of Niagara Police Department. |

| 6/8 | Baseline Rd. | Exposure | The complainant states she was working out at Snap Fitness when a male subject came to the front window, exposed his genitals and began to masturbate. The subject left in a dark colored SUV prior to the arrival of Patrol. Deputies checked that area but were unable to locate the male by the description given. The suspect was described as being white male, in his 30's, short in stature, scruffy beard. |
| 6/8 | Broadway | Shots Fired | The complainant states that she heard a single gunshot then saw several subjects running from the area. Deputies checked the area but were unable to locate the subjects by the description given. The sound appeared to be a firework. |
| 6/9 | Love Rd. | Drunk Driving | Deputies responded to a report of 1 car motor vehicle accident near Baseline Rd. Their investigation led to the arrest of 32 y/o Valerie Gasbarro of Grand Island for Driving While Intoxicated. Gasbarro registered a .10% BAC after submitting a sample of her breath for chemical analysis. Gasbarro was issued an appearance ticket returnable to the Town of Grand Island Court and released to a sober 3 rd party. |
| 6/9 | Grand Island Blvd. | Accident PDO | Deputies responded to a report of a 1 car motor vehicle accident in the parking lot of McDonald's. No injuries were reported. |
| 6/9 | Bedell Rd. | Suspicious Incident | The complainant states that he came home and found his apartment had been trashed and his dogs were let out. Nothing was reported stolen. |
| 6/9 | Warner Dr. | Suspicious Person | The complainant states that 3 male subjects were going door to door soliciting for the Green Co Home Service. Deputies located the subjects nearby and advised them to obtain the proper paperwork to solicit in the Town of Grand Island. |
| 6/9 | Bedell Rd. | Larceny | The complainant states that a known person(s) stole various items from his residence. The complainant was not interested in pursuing charges and only wanted the subject advised. |
