The Erie County Sheriff's Office responded to 289 calls the week of this report. Below is a sampling of the noteworthy incidents in **Grand Island**.

Date	Type	Street	Narrative
6/6	Fire - Residential	Staley Rd.	Deputies responded along with State Police and Fire EMS to a possible house fire. Deputies arrived on location to find the roof smoking heavily with signs of fire. Fire was able to get engines on scene and put the fire out. Homeowner explained that she was using a heat gun to remove old paint in the soffit and it just lit up. Report taken.
6/7	Larceny from Vehicle	Marilyn Dr.	Deputies responded to the area of Marilyn Dr. for unlocked vehicle's entered overnight. Subject on Marilyn Dr. had wallet taken from vehicle and her Discover card was used. Detectives are following up with 7-11 for video. Several other vehicle's had change taken from them. PLEASE remember to lock your doors at night.
6/7	Disturbance in Progress	Budget Motel	Deputies went to the Budget in for a male beating on things with a stick. Deputies arrived and the scene was calm. Spoke to all individuals involved and appeared to be a misunderstanding. All parties advised.
6/8	Mental	Falls Link Rd.	Deputies were called to a residence on Falls Link Rd. for a female who possibly took too many pills on purpose. Subject was evaluated by Deputies and transported to ECMC on MHL 9.41 for further evaluation.
6/9	Larceny from Vehicle	Heron Pointe Apts.	Deputies were called to Heron Pointe for vehicles gone through overnight. One subject had his wallet taken and credit cards were used. Days later another resident in the complex noticed their vehicle was missing and reported it as stolen. PLEASE lock your doors at night.
6/10	Disturbance Other	Elmwood Rd.	Deputies were contacted by male stating neighbors are in a heated argument and it seems to be getting worse. Deputies located the brother and sister arguing and spoke with them and the mother. Mother handled and patrol advised.
6/11	Suspicious Person – Warrant Serve	Budget Motel	Deputies came upon a suspicious person(s) at the Budget Motel. Upon speaking with them and identifying them as Angela Billingsley (54) and Jason George (41) it was discovered that both had active warrants out of the Town of Tonawanda. They were detained and turned over to Tonawanda PD.

6/12	Unknown Trouble - Mental	Grand Island Bd.	Deputies responded to a female at the bus stop who took off all her clothes and paced around but now is dressed again. Deputies spoke with the female at the bus stop and assisted her with a ride to Trinity Church to get assistance. Deputies received a call from Trinity Church a short while later saying the female is now naked running down Whitehaven Rd. Deputies secured the female and she was eventually taken to ECMC for evaluation.
