The Erie County Sheriff's Office responded to 188 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

| 6/6 | Love Rd. | Unauthorized Use of a Motor Vehicle | The complainant states that her daughter took her vehicle without her permission and refused to return the car. The vehicle was listed as stolen and was later recovered in the City of Buffalo. Investigation Ongoing. | |
| 6/6 | East River Rd. | Suspicious Person with Vehicle | The complainant states that 3 male subjects in different vehicles were at the neighbor's house and did not seem to belong there. Deputies spoke with the subjects and determined they were contractors completing work on the neighbor's residence. | |
| 6/6 | Bedell Rd. | Suspicious Incident | The complainant states that she observed a scratch on her vehicle and was unsure how it got there. | |
| 6/6 | Pin Oak Cr. | Reckless Operation | Deputies received a call from the Town of Tonawanda Police Department about a vehicle travelling recklessly on the I-290. The registered owner was reported to live on Grand Island and it seemed the car was headed toward the address. Deputies checked the area but were unable to locate the vehicle. | |
| 6/6 | East River Rd. | Loud Music | The complainant states that loud music was coming from a nearby address during the late evening hours. Deputies spoke with the occupants of the house in question and advised them. | |
| 6/6 | Forest Creek Ct. | Youth Activity | The complainant states that several youths were in the area ringing door bells and knocking then fleeing. The complainant chased the youths to a nearby address. Deputies located all the youths and advised them. The youths were turned over to the custody of their guardian. | |
| 6/7 | Baseline Rd. | Suspicious Person | Deputies located 4 subjects riding bicycles during the late hours of the night. The subjects were returning home from 711 and were advised. | |
| 6/7 | Love Rd. | Drunk Driving | Following a traffic stop, Deputies arrested 55 y/o Christa Sheppard of Grand Island for Driving While Intoxicated and other traffic infractions. Sheppard registered a .21% B.A.C. after submitting a sample of her breath for chemical analysis and was further charged with Aggravated Driving While Intoxicated due to the elevated reading. | 6/7 | Grand Island Blvd. | Accident PDO | Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of Tim Hortons. No injuries were reported. | |
| 6/7 | Grand Island Blvd. | Threat | The complainant states that while he was at First Niagara Bank an intoxicated male subject on a bicycle threatened him before leaving the area. Deputies checked the area but were unable to locate the male subject. | |
| 6/7 | Grand Island Blvd. | Suspicious Incident | The complainant states that 2 suspicious male subjects were repeatedly driving through the parking lot of her apartment complex. Deputies located the subjects who were looking for a friend who lived in the complex. | |
| 6/8 | Foxcroft St. | Barking Dog | The complainant states that a dog at a nearby residence was barking for the last several hours late at night. Deputies were unable to make contact with the occupants. | |
| 6/8 | Grand Island Blvd. | Accident Injury | Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of Theodore's. 2 subjects were treated on scene for seemingly minor injuries. | |
| 6/8 | Grand Island Blvd. | Suspicious Incident | Employees from Tops state that a customer drove off without paying for fuel but believed it was a mistake on his behalf. Deputies located the customer who returned to pay for the fuel. | |
| 6/8 | Grand Island Blvd. | Traffic Arrest | Following a traffic stop, Deputies arrested 19 y/o Paul Long of Grand Island for Aggravated Unlicensed Operation 3 rd Degree (Misdemeanor), other traffic infractions and Unlawful Possession of Fireworks after a DMV check showed his license was currently suspended. Long was issued an appearance ticket returnable to the Town of Grand Island. | |
| 6/9 | East Park Rd. | Larceny | The complainant states a known subject stole money from her purse while he was a guest at her house. The complainant did not wish to pursue charges against the subject. | |
| 6/9 | Long Rd. | Suspicious Person | The complainant states that a male subject was walking in and out of properties in the area. Deputies checked the area but were unable to locate the subject by the description given. | |
| 6/9 | Center Court North | Animal Complaint | The complainant states that a neighbor's dog jumped her dog. The Dog Control Officer was notified. | |
| 6/10 | Stony Point Rd. | Accident PDO | Deputies responded to a report of a 2 car motor vehicle accident near the intersection of Cardinal La. No injuries were reported. | |
| 6/10 | Bedell Rd. | Suspicious Incident | The complainant states that she thought she heard glass breaking and her dog was acting strange. Deputies checked the residence and found everything was in order. | |
| 6/10 | East Park Rd. | Reckless Operation | The complainant states that a vehicle was speeding in an out of the neighborhood. Deputies checked the area but were unable to locate the vehicle by the description given. | |

| 6/10 | Love Rd. | Larceny | The complainant states that 2 youths just stole traffic cones from the construction zone on the corner of East Park Rd. Deputies checked the area but were unable to locate the subjects by the description given. |
| 6/10 | South State Pkwy. | Obstruction | Following a traffic stop, Deputies arrested 27 y/o Salvatore Santalucia of Niagara Falls for Obstruction 2 nd Degree (Class A Misdemeanor), Resisting Arrest (Class A Misdemeanor) and other traffic infractions. Santalucia was transported to the Erie County Holding Center in lieu of \$500 bail. |
| 6/11 | Alt Blvd. | Suspicious Person | The complainant states that a male and female were on the side of the roadway and the female appeared to be rolling around on the ground. Deputies located the 2 subjects and advised them. |
| 6/11 | Grand Island Blvd. | Accident PDO | Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of Theodores. No injuries were reported. |
| 6/11 | Hazelwood Ct. | Suspicious Incident | The complainant states that a subject was at a nearby residence which was vacant and was walking around the property. The subject left prior to the arrival of Patrol. No damage was observed to the residence. |
| 6/12 | West Oakfield Rd. | Suspicious Incident / Narcotics Arrest | The complainant states that a female subject tried to rob his friend and he was able to follow the female in her vehicle to West Oakfield Rd. Deputies located both subjects on West Oakfield Rd. Their investigation led to the arrest of 22 y/o Jessie-Maria Miller of Niagara Falls for Possession of a Hypodermic Instrument (Class A Misdemeanor), Criminal Possession of a Controlled Substance 7 th Degree (Class A Misdemeanor), Aggravated Unlicensed Operation 3 rd Degree (Misdemeanor) and other traffic infractions. Miller was issued an appearance ticket returnable to the Town of Grand Island Court. |
| 6/12 | Baseline Rd. | Accident PDO | Deputies responded to a report of a 2 car motor vehicle accident at the intersection of Grand Island Blvd. No injuries were reported. |
| 6/12 | Ransom Rd. | Reckless Operation | The complainant states that a motorcycle was driving on the sidewalk in front of the Grand Island High School. Deputies checked the area but were unable to locate the vehicle by the description given. |
| 6/12 | Beaver Island State Park | Wires Down | Deputies responded to a report of wires down near the entrance to the park on West Oakfield Rd. National Grid was notified. |
| 6/12 | Whitehaven Rd. | Larceny | The complainant states that while she was at Byblos Niagara Resort & Spa an unknown person stole her wallet from her purse. |
| 6/12 | Grand Island Blvd. | Suspicious Incident | The complainant states that a male subject was sleeping in his vehicle in the parking lot of Tops. Deputies located the male subject who was tired from driving and pulled over to the side of the road to rest. |
