



## Erie County Sheriffs Office Media Release Summary

The Erie County Sheriff's Office responded to 191 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

5/21	Center Terr.	Suspicious Incident	The complainant states she came home and found her apartment door had been damaged and thought a person might be inside. Deputies searched the apartment but found no persons or signs of a disturbance inside.
5/21	Parkview Dr.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
5/22	Whitehaven Rd.	Disorderly Person	The complainant states that 2 subjects were in a vehicle nearby and doing inappropriate things. Deputies located the subjects nearby and advised them. The subjects left without incident.

5/23	Grand Island Blvd.	Suspicious Person with Vehicle	The complainant states that a male subject was sleeping behind the wheel of a parked car in the Rite Aid parking lot. Deputies located the subject and were able to wake him. The subject was advised and left without incident.

5/23	South State Pkwy.	Traffic Complaint	The complainant states that a vehicle was traveling in the wrong direction on South State Pkwy. Deputies checked the area but found no vehicles in the wrong lanes of travel.
5/23	Ransom Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
5/23	Stony Point Rd.	Trespass	2 complainants state that a male subject walked into their residence and appeared to be intoxicated. Deputies located the subject nearby. Neither complainant wished to pursue any charges and the subject was advised and left without further incident.

5/24	East River Rd.	Noise Complaint	The complainant states that loud music was coming from a nearby residence. Deputies checked and determined the complaint was unfounded.

Traffic Arrest	Following a traffic stop, Deputies arrested 49 y/o John Kilmer Jr. of Grand Island for Aggravated Unlicensed Operation 2 <sup>nd</sup> Degree (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently revoked. Kilmer was issued an appearance ticket returnable to the Town of Grand Island Court.
5/25	Waterford Pk.	Traffic Complaint	The complainant states that a white colored car was speeding through the neighborhood over and over again. Deputies checked the area but were unable to locate the vehicle by the description given.
5/25	East River Rd.	Suspicious Incident	The complainant states that she arrived home and found a light on inside the residence that she didn't remember leaving on. Deputies checked the residence but found no persons or signs of a disturbance inside.
5/25	East River Rd.	Suspicious Person with Vehicle	Deputies located an occupied vehicle at Fishermans Landing during the late hours of the night. The occupants were advised and left without incident.
5/26	I-190	Marijuana Possession	Following a traffic stop, Deputies arrested 37 y/o Dustin Bauer of Niagara Falls for Unlawful Possession of Marijuana (Violation) and a traffic infraction. Bauer was issued an appearance ticket returnable to the Town of Grand Island Court.
5/26	East River Rd.	Suspicious Person with Vehicle	Deputies located a suspicious vehicle parked in the lot of the Buffalo Launch Club during the late hours of the night. The occupants were determined to be employees.
5/26	East River Rd.	Suspicious Person with Vehicle	Deputies located an occupied vehicle parked in Buckhorn State Park during the late hours of the night. The occupants were advised and left without incident.
5/26	Stony Point Rd.	Suspicious Person	The complainant states that a male subject was walking down the road in full fatigues and was carrying a

			weapon. Deputies located the subject nearby and determine he exited the woods from turkey hunting in the wrong spot and became lost.
5/26	Bedell Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke to the occupants and determined the call to be a misdial.
5/26	Baseline Rd.	Accident Injury	Deputies responded to a report of a 2 car motor vehicle accident at the intersection of Whitehaven Rd. 1 person was transported to a local hospital with seemingly non-life threatening injuries.
5/26	Baseline Rd.	Fireworks Use	The complainant states that someone was using fireworks in the area. Deputies checked the area but were unable to locate anyone using fireworks.
5/27	Long Rd.	Warrant Arrest	Deputies arrested 29 y/o Adam Gennuso of Grand Island on an outstanding Arrest Warrant from Chautauqua County. Gennuso was transferred to the custody of the Chautauqua County Sheriffs Office.
5/27	Fix Rd.	Accident Injury	Deputies responded to a 1 car motor vehicle accident involving a bicyclist. The Bicyclist was transported to a local hospital with seemingly non-life threatening injuries.
5/27	West River Rd.	Suspicious Person with Vehicle	Deputies located an occupied vehicle at the Whitehaven Rd. overlook during the late hours of the night. The occupants were advised and left without incident.
