



Erie County Sheriffs Office Media Release Summary

The Erie County Sheriff's Office responded to 194 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
6/8	Grand Island Blvd.	Reckless Operation	Complainant states that a vehicle was parked in the drive thru of Tim Hortons and it appeared the driver was sleeping. The vehicle left in an unknown direction prior to the arrival of Patrol. Deputies checked the area but were unable to locate the vehicle.
6/8	Grand Island Blvd.	Property Found	Complainant states he found a females wallet in the parking lot of McDonald's. Deputies contacted the owner and the property was returned.
6/8	South La.	Parking Violation	Complainant states that a vehicle was parked the wrong way on the street. Deputies located the owner and advised him.
6/8	Winkler Dr.	Suspicious Incident	Complainant states that sometime in recent hours someone had damaged her mailbox. Deputies did not observe any damage to the mailbox which was put back into place by the complainant.
6/8	Hazelwood La.	Loud Music	Complainant stated that loud music was being played from a nearby residence. Deputies spoke to the occupants who agreed to turn the music down.
6/9	Calvano Dr.	Suspicious Vehicle	Deputies located a suspicious vehicle occupied by numerous subjects during the late hours of the night. The subjects were advised and left without incident.
6/9	East River Rd.	Drunk Driving	Following a traffic stop, Deputies arrested 29 y/o Max Nelson of Tonawanda for Driving While Intoxicated. Nelson registered a .17% B.A.C. after submitting a sample of his breath for chemical analysis. Nelson was also charged with Felony Driving While Intoxicated due to a previous conviction of DWI in the last 10 years. Nelson was transported to the Erie County Holding Center pending his arraignment in the Town of Grand Island Court.
6/9	Whitehaven Rd.	Suspicious Incident	Deputies found several hypodermic needles located in the parking lot of Noco. The needles were removed from the lot and discarded in a biohazard medical waste container.
6/9	Grand Island Blvd.	Disorderly Person	Employees of Fantasy Island state that an intoxicated

			male subject was causing a disturbance on the premise. The subject was escorted from the park without further incident.
6/9	Riverview Ct.	Animal Complaint	Complainant states that a large turtle was in the roadway and was worried it would be struck by a vehicle. Deputies relocated the turtle to the side of the road.
6/9	Baseline Rd.	Reckless Operation	Complainant states that a vehicle was travelling slowly down the road. Deputies located the vehicle at a nearby residence and advised the driver.
6/9	Ransom Rd.	Loud Music	Complainant states that loud music was coming from a residence in the area. Deputies checked and determined the complaint to be unfounded.
6/10	Staley Rd.	Animal Complaint	Complainant states that a horse was running loose and believed the animal belonged to a neighbor. Deputies checked the area but did not observe any loose horses.
6/10	Whitehaven Rd.	Larceny	Employees at Holiday Inn stated that a guest wished to speak with Patrol about a larceny that occurred from their hotel room. The guest checked out and left prior to speaking with Patrol.
6/10	Grand Island Blvd.	Suspicious Person	Complainant states that he saw an elderly female standing beside the road and remembered seeing her there a few hours ago. Deputies checked the area but were unable to locate the female.
6/10	Grand Island Blvd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
6/11	Whitehaven Rd.	Suspicious Person	Deputies located a female subject walking on the road during the late hours of the night. The female stated she was walking home from work.
6/11	West River Rd.	Criminal Mischief	Complainant states that sometime during the night, an unknown person(s) slashed the tires on his vehicle and keyed it.
6/11	East River Rd.	Accident Hit & Run	Complainant states that a vehicle drove over his lawn and damaged his concrete driveway. Deputies were able to locate the driver from pieces of the suspect vehicle left at the accident scene. The driver was issued traffic tickets returnable to the Town of Grand Island Court.
6/11	Whitehaven Rd.	Reckless Operation	Complainant states that a vehicle was swerving in and out of lanes on the I-190. The vehicle then exited at Whitehaven Rd. and the complainant lost sight of it. Deputies checked the area but were unable to locate the vehicle.
6/11	Bedell Rd.	Criminal Mischief	Complainant states that an unknown person(s) damaged picnic tables at the Miracle League Field in Veterans Park by removing planks of wood from them. No further damage was observed.
6/11	Ward Pk.	Suspicious Person with Vehicle	Complainant states that a suspicious female subject was rummaging through garbage cans in the neighborhood and appeared to be on drugs. Deputies checked the area but were unable to locate the subject.
6/11	Fix Rd.	Suspicious Vehicle	Complainant states that a vehicle was parked in the driving lane on the roadway. Deputies located the vehicle which was not in any violations of parking ordinances.

6/12	Whitney La.	Larceny	Complainant states that a male subject was walking on the street late at night and appeared to have entered his neighbor's vehicle. Deputies checked the area but were unable to locate the subject. The vehicle in question was reported as having several items missing. Investigation Ongoing.
6/12	Baseline Rd.	Person Down	Complainant states that a subject was lying in the ditch on the side of the road. Deputies located the intoxicated subject and gave him a courtesy ride to his residence.
6/12	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
6/12	Grand Island Blvd.	Forgery	Employees at Wendy's state that a subject passed a counterfeit \$20 bill at the restaurant. Investigation Ongoing.
6/12	Baseline Rd.	Suspicious Person with Vehicle	Complainant states that a suspicious looking male subject was in a white van parked on the road. Deputies checked the area but were unable to locate the subject.
6/12	Love Rd.	Reckless Operation	Complainant states that a vehicle was swerving and cutting off other vehicles. The complainant lost sight of the vehicle while Patrol was responding. Deputies checked the area but were unable to locate any vehicles matching the description.
6/12	Marilyn Dr.	Suspicious Person	Complainant states that a male subject was inside of his garage during the late hours of the night. When the complainant asked the male what he was doing the subject responded he had permission to be there. The subject then left in an unknown direction. Deputies checked the area but were unable to locate the subject. Nothing was reported missing or damaged.
6/13	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
6/13	East River Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
6/13	Tracey La.	Larceny	Complainant states that she left her purse on the driveway while unloading groceries from the store. The complainant found her purse on Laurie La. but the contents were missing. The complainant did not observe any subjects in the area.
6/13	Wallace Dr.	Criminal Mischief	Complainant states that an unknown person(s) egged his house.
6/13	Stony Point Rd.	Reckless Operation	Complainant states that a vehicle was driving on the wrong side of the roadway. The vehicle pulled into a garage of a nearby residence shortly after. Deputies spoke to the driver and advised her.
6/14	Schwegler Rd.	Suspicious Person with Vehicle	Deputies located a parked vehicle occupied by several subjects during the late hours of the night. The subjects were advised and left without incident.
6/14	West Park Rd.	Shots Fired	Complainant stated she heard a single gunshot ring out but was unsure of where it came from. No other 911 calls were received. Deputies checked the area and determined the complaint to be unfounded.
6/14	Huth Rd.	Accident Hit & Run	Complainant states that a vehicle struck a street sign and left glass on the roadway from the collision. Deputies

			checked the area but were unable to locate the vehicle in question. No damage was done to the sign.
6/14	Park Pl.	Youth Activity	Complainant states that 2 youths were riding a golf cart in the roadway and were almost struck by a vehicle. Deputies checked the area but were unable to locate the youths.
6/14	East River Rd.	Suspicious Person	Complainant states that 2 subjects were going door to door and soliciting for money. Deputies located the subjects and advised them to file the proper paperwork with the Town of Grand Island. The subjects left without incident.
6/14	East River Rd.	Youth Activity	Complainant states a large group of youths was walking around with flashlights and making a lot of noise during the late hours of the night. Deputies located the youths and advised them.

Deputies responded to 15 Burglary False alarm calls and 3 Fire Alarms during the dates of this report.
