The Erie County Sheriff's Office responded to 231 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

6/11	Ransom Rd.	Warrant Arrest	Following an investigation of an unrelated incident, Deputies arrested 39 y/o Sean Hurley of Grand Island after a check showed he had an outstanding warrant from the Town of Tonawanda. Hurley was transferred to the custody of the Town of Tonawanda Police Department.
6/11	Grand Island Blvd.	Larceny	Employees of Tops state that a male subject came into the store and was concealing items under his coat. The subject was confronted by employees in the parking lot and he dropped the stolen merchandise before fleeing in a blue minivan. No other items were reported missing. Deputies checked the area but were unable to locate the subject or vehicle by the description given.

6/11	Ransom Rd.	ATV Complaint	The complainant states that 2 ATV's were parked next to the tennis courts at Grand Island High School. Deputies checked the premise but were unable to locate any ATV's.
6/11	Grand Island Blvd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
6/11	Alvin Rd.	Traffic Complaint	The complainant states that a vehicle was following her because she didn't move fast enough through a green light. Deputies located the vehicle and advised the driver.
6/11	Staley Rd.	Accident PDO / Traffic Arrest	Deputies responded to a report of a 2 car motor vehicle accident on Staley Rd. No injuries were reported. Their investigation led to the arrest of 1 of the drivers 23 y/o M. Winkfield of Niagara Falls for Aggravated Unlicensed Operation 3 rd Degree (Misdemeanor) and other traffic infractions. Winkfield was issued an appearance ticket returnable to the Town of Grand Island Court.
6/11	Grand Island Blvd.	Suspicious Incident	The complainant states that a male subject was sitting in a vehicle in the Tops parking lot screaming. Deputies located the vehicle nearby and advised the driver.

6/11	Grand Island Blvd.	Larceny	The complainant states that while she was at Fantasy Island, an unknown person(s) stole her cell phone from her unattended bag.
6/11	Stony Point Rd.	Fireworks Use	The complainant states that subjects at a residence nearby were using fireworks. Deputies checked the area and determined the complaint was unfounded.
6/11	Colonial Dr.	Suspicious Incident	The complainant states that she saw a subject with a flashlight in her backyard during the late hours of the night. Deputies checked the area but were unable to locate any subjects.
6/12	Broadway	Animal Loose	The complainant states that his dog got out during the late hours of the night and was running loose in the area. The Dog Control Officer was notified.

Traffic Arrest / Warrant Arrest	Following a traffic stop, Deputies arrested 49 y/o Enoch Cray Jr. of Rochester for Aggravated Unlicensed Operation 1 st Degree (Felony) and other traffic infractions after a DMV check showed his license was currently revoked with a total of 46 suspensions on his license. Cray was transported to the Erie County Holding Center pending his arraignment in the Town of Grand Island Court. Also arrested was the passenger of the vehicle, 43 y/o Lisa Lee of Niagara Falls after a check showed she had an outstanding warrant. Lee was also transported to the Erie County Holding Center.
6/14	I-190	Traffic Arrest	Following a traffic stop, Deputies arrested 27 y/o Nicholas Retzlaff of Niagara Falls for Operating a motor vehicle with a suspended registration (Misdemeanor) and other traffic infractions after a DMV check showed his registration was currently suspended. Retzlaff was issued an appearance ticket returnable to the Town of

6/14	I-190	Warrant Arrest	Following traffic stop, Deputies arrested 35 y/o Jerry Williams of Buffalo after a check showed he had 3 outstanding warrants, 2 from the City of Buffalo and 1 from Town of Tonawanda. Williams was transferred to the custody of the Town of Tonawanda Police Department.
6/15	Riverdale Dr.	Fireworks Use	The complainant states that subjects were using fireworks in the area around his house. Deputies checked the area but were unable to locate any persons using fireworks.
6/15	Bedell Rd.	Suspicious Person	The complainant states that a subject was walking in front of the Country Glen Apartments yelling at himself during the late hours of the night. Deputies located the subject who was singing along to music from his headphones. The subject was advised and left without incident.
