The Erie County Sheriff's Office responded to 159 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

6/15	South Sate Pkwy.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
6/15	Stony Point Rd.	Animal Loose	Complainant states that a dog was running loose in the neighborhood. The Dog Control Officer was notified.
6/15	Grand Island Blvd.	Reckless Operation	Complainant states that several motorcycles were driving recklessly from the airport and she then saw them at a repair shop on Grand Island. Deputies located the drivers of the motorcycles and advised them.
6/15	Bedell Rd.	Welfare Check	Complainant states that a male subject was walking on the roadway and appeared to have been in some kind of fight. Deputies located the subject who was just walking home from a local business.

6/17	Lakeview Te.	Disorderly Person	Complainant states that employees from a landscaping company were urinating on the apartment building while working on the premise. Deputies spoke to the employees and advised them.

6/18	Wallace Dr.	Animal Complaint	Complainant states that a young child was walking a large dog and the animal was dragging him around and chasing other people. Deputies determined the complaint to be unfounded.

6/20	Beaver Island State Park	Disorderly Person	Complainant states that several subjects were making a lot of noise while at the Marina during the late hours of the night. Deputies determined the complaint to be unfounded.
6/21	Long Rd.	Loud Music	Complainant states that loud music was coming from a nearby residence during the late hours of the night.  Deputies spoke to the home owner who agreed to turn the music down.
6/21	Stony Point Rd.	Larceny	Complainant states that sometime during recent days, an unknown person(s) stole various items from her unlocked vehicle.
6/21	East River Rd.	Reckless Operation	Complainant states that a vehicle was swerving all over the roadway but was unable to get any license plate information. Deputies checked the area but were unable to locate the vehicle.
6/21	Waterford Pk.	Suspicious Incident	Complainant states that an unknown person(s) was pounding on his door during the late hours of the night and then ran off. Deputies checked the area but were unable to locate any subjects. A Frisbee was left on the front porch of the complainant's residence but no damage was observed.
