



Erie County Sheriffs Office Media Release Summary

The Erie County Sheriff's Office responded to 162 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
5/23	Whitehaven Rd.	Suspicious Incident	Deputies located a mailbox in the roadway during the late hours of the night. It was determined the mailbox was hit by a vehicle attempting to back out of a driveway.
5/23	Whitehaven Rd.	Drunk	The complainant states that a male subject was sleeping in the lobby of Byblos Niagara Resort & Spa and appeared to be highly intoxicated. The male subject was located and transported to a local hospital for evaluation.
5/23	East River Rd.	Warrant Arrest	Deputies arrested 29 y/o Alexander Hrusa of Grand Island on an outstanding bench warrant from the Niagara County Sheriff's Office. Hrusa was transferred to the custody of NCSO.
5/23	East River Rd.	Suspicious Person	The complainant states that a male subject was walking down the road and appeared to be flagging down cars. Deputies located the subject and advised him.
5/23	I-190	Assists Other Police	Deputies assisted the New York State Troopers with a report of a motor vehicle accident with injuries on the thruway.
5/23	Grand Island Blvd.	Refer to Patrol	The complainant states that a male subject in a pickup truck was dumping refuse behind the apartment building. Deputies located the subject nearby and advised him.
5/24	Enola Rd.	Reckless Operation	The complainant states that a neighbor continuously races his car up and down the street and wanted the subject to be advised. Deputies spoke with and advised the subject.
5/24	Baseline Rd.	Youth Activity	The complainant states that several youths were on the roof of St. Stephens Church. Deputies located the subjects and advised them at the request of employees of the church.
5/24	Love Rd.	Youth Activity	The complainant states that several youths appeared to be trying to pry open a metal container in the parking lot of Kaegebein Elementary School. Deputies checked the area but were unable to locate the youths. No damage was observed.
5/24	East River Rd.	Barking Dog	The complainant states that the dogs at a nearby

			residence were barking for the last several hours late at night. Deputies were unable to make contact with the homeowners of the house in question. The Dog Control Officer was notified.
5/24	Fareway La.	Loud Music	The complainant states that loud music was coming from a nearby residence during the late hours of the night. Deputies located the house and advised the occupants.
5/24	Sandy Beach Rd.	Fireworks Use	The complainant states that a nearby neighbor was setting off fireworks during the late hours of the night. Deputies checked but were unable to locate any subjects using fireworks.
5/25	West Park Rd.	Accident Injury	Deputies responded to a report of a 1 car motor vehicle rollover accident. The driver was transported to a local hospital with seemingly non-life threatening injuries. Deputies issued numerous traffic tickets to the driver and the driver of another vehicle after determining the cars seemed to be travelling at a high rate of speed through the neighborhood.
5/25	Grand Island Blvd.	Larceny	The complainant states that an unknown person(s) stole various items from her unsecured vehicle while it was in the Tops parking lot.
5/25	East River Rd.	Suspicious Person	The complainant states that a male subject was going door to door knocking and seemed to be intoxicated. Deputies located the subject nearby and advised him. The subject left without further incident.
5/25	Laurie La.	Suspicious Person with Vehicle	The complainant states that the occupants of 2 vehicles parked at the corner appeared to be conducting a drug deal. Deputies checked the area but were unable to locate any vehicles matching the description given.
5/25	West River Pkwy.	Suspicious Incident	The complainant states that a female subject was sleeping behind the wheel of her vehicle in the parking area off of the parkway. The vehicle left in a southbound direction prior to the arrival of Patrol. Deputies checked the area but were unable to locate the vehicle by the description given.
5/25	Grand Island Blvd.	Suspicious Vehicle	The complainant states that a vehicle pulled over to the side of the road and the occupants walked away from the vehicle in an unknown direction during the late hours of the night. Deputies located the vehicle which had extensive damage from being involved in an accident. The occupants were located nearby. It was determined the vehicle was involved in an accident on the I-190 that the NYS Troopers were handling. The occupants were turned over to the NYS Troopers.
5/26	Love Rd.	Burglary	Deputies responded to a burglary alarm at Sunoco and upon arrival observed the front door to the business was smashed. Patrol searched the premise but found no persons inside. Various items were reported stolen by the owner who responded to the scene at Patrols request. Surveillance cameras inside the business captured the event on video and the Erie County Sheriff's Office Detective Bureau is following up on the case.
5/26	Baseline Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become

			disabled.
5/26	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
5/26	Marlin Dr.	Suspicious Person	The complainant states she came home and found a female subject sleeping on her porch during the late evening hours. Deputies spoke with the subject and determined she was looking for a nearby family members residence. The subject's family was contacted and the parties were re-united.
5/27	First St.	Reckless Operation	The complainant states that a subject driving a motorcycle was speeding down the street and it is an ongoing issue. Deputies checked the area but were unable to locate the motorcyclist.
5/27	East River Rd.	Suspicious Person	The complainant states that 4 male subjects were walking on top of the intake and then went on a boat and were no in the middle of the river. Deputies spoke with the subjects and determined they were conducting a survey for fish and wildlife in the area.
5/27	Love Rd.	Reckless Operation	The complainant states that a vehicle was driving recklessly on the I-190 and then exited the thruway and headed down South State Pkwy before the complainant lost sight of it. Deputies checked the area but were unable to locate the vehicle by the description given.
5/28	Whitehaven Rd.	Wires Down	Deputies responded to a report of wires down in the roadway.
5/28	White Tail Run	Property Found	The complainant states he found 2 bicycles in the culvert and no one was around. Deputies took possession of the bikes and transported them to the Substation.
5/28	Grand Island Blvd.	Accident Injury	Deputies responded to a report of a 2 car motor vehicle accident. The drivers of both vehicles were transported to a local hospital with seemingly non-life threatening injuries.
5/28	Grand Island Blvd.	Suspicious Person with Vehicle	Deputies located an occupied vehicle parked in the lot of a closed business during the late evening hours. The driver was determined to be an employee of the business.
5/28	Islewoods St.	Suspicious Incident	The complainant states that she arrived home during the late hours of the night and found her door was unlocked and a light was on inside the house. Deputies checked the residence but found no persons or signs of a disturbance inside.
5/29	East River Rd.	Suspicious Person with Vehicle	Deputies located an occupied vehicle parked in Fisherman's Landing during the late hours of the night. The occupants were advised and left without incident.
5/29	Stony Point Rd.	Wires Down	Deputies responded to a report of wires down in the roadway. The wires were determined to be traffic counters.
5/29	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of Tim Hortons. No injuries were reported.
5/29	West River Rd.	Open Burn Complaint	The complainant flagged down Patrol to report a campfire in a nearby backyard that was unattended and it did not appear the occupants were home. Deputies extinguished the small campfire.

5/29	Grand Island Blvd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled near the intersection of Long Rd.
