



## Erie County Sheriffs Office Media Release Summary

The Erie County Sheriff's Office responded to 207 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

5/28	Sixth St.	Accident Hit & Run	The complainant states that a dark colored car struck her mailbox during the late hours of the night and then fled the scene. Deputies checked the area but were unable to locate the vehicle by the description given.
5/28	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the lot of Tim Hortons. No injuries were reported.
5/28	East River Rd.	Accident Hit & Run	The complainant states that an unknown person struck his vehicle while it was parked at Blue Water Marina sometime in recent hours.
5/28	Bedell Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle became disabled near the intersection of Grand Island Blvd.
5/29	Wallace Dr.	Suspicious Incident	The complainant states that when she awoke in the morning she found the screen door missing and her interior door was askew. Nothing was reported damaged or stolen and it did not appear anyone made entry into the residence.
5/29	Woodstock Rd.	Suspicious Person	The complainant states that a male subject was yelling and screaming in the roadway. Deputies located the subject and advised him.
5/29	Grand Island Blvd.	Property Found	The complainant states he found a wallet and wanted to turn it over to Patrol.
5/29	Stony Point Rd.	Traffic / Narcotics Arrest	Following a traffic stop, Deputies arrested 49 y/o William Marshall of Grand Island for Aggravated Unlicensed Operation 2 <sup>nd</sup> Degree (Misdemeanor), Criminal Possession of a Controlled Substance 7 <sup>th</sup> Degree (Class A Misdemeanor) and other traffic infractions after a DMV check showed his license was currently revoked. Marshall was issued an appearance ticket returnable to the Town of Grand Island Court.
5/30	East River Rd.	Suspicious Incident	The complainant states he was riding his bicycle in the area and noticed a vehicle was following him. The complainant hid from the vehicle for a while but when he started moving again, the vehicle spotted him and still followed him. The vehicle left the area prior to the

			arrival of Patrol. Deputies checked but were unable to locate the vehicle by the description given.
5/30	Sheree Dr.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
5/30	Bedell Rd.	Suspicious Person	The complainant states that several youths were in Veterans Park playing loud music from a vehicle and smoking marijuana. Deputies checked the area but were unable to locate the youths by the description given.
5/30	Whitehaven Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle became disabled in the parking lot of the Byblos Niagara Resort & Spa.
5/31	East River Rd.	Accident Injury / Driving While Intoxicated	Deputies responded to a report of a 2 car motor vehicle accident. Their investigation led to the arrest of 31 y/o Lauren Metz of Buffalo for Driving While Intoxicated and other traffic infractions. Metz was issued an appearance ticket returnable to the Town of Grand Island Court. 2 drivers were transported to local hospitals with seemingly non-life threatening injuries.
5/31	Grand Island Blvd.	Fight	The complainant states that 2 males were fighting in front of his residence and then took off on bicycles. Deputies located the subjects nearby and advised them. Neither party was interested in pursuing charges and no person was injured.
5/31	Bedell Rd.	Criminal Mischief	The complainant states that sometime in recent days, an unknown person(s) keyed her car causing damage.
5/31	White Tail Run	Animal Loose	The complainant states she found a dog running loose in the area. The dog was reunited with the owner.
5/31	Pin Oak Cr.	Suspicious Person	The complainant states that 2 male subjects were going door to door soliciting for the Wounded Warrior Project. Deputies located the subjects nearby and advised them to obtain the proper paperwork to solicit in the Town of Grand Island.
5/31	Grand Island Blvd.	Marijuana Possession	Following a traffic stop, Deputies arrested 24 y/o Anthony Andrade of Simpsonville SC for Criminal Possession of Marijuana (Class A Misdemeanor) and traffic infractions. Andrade was issued an appearance ticket returnable to the Town of Grand Island Court.
5/31	Whitehaven Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
6/1	Fareway La.	Suspicious Person	The complainant states he observed a male subject with a flashlight on his head looking into vehicles during the late hours of the night. The male subject fled after being scared by a dog in the area. Deputies checked but were unable to locate the subject by the description given.
6/1	Steeg Rd.	Youth Activity / Warrant Arrest	The complainant states that 4 youths were driving around the area smoking marijuana. Deputies located the vehicle parked at the Sandy Beach Yacht Club and spoke with the occupants. Their investigation led to the arrest of 20 y/o Darius Brown of Buffalo after a check showed he had an outstanding warrant from the City of Buffalo. Brown was transferred to the custody of the Buffalo Police Department. The other subjects were advised and left without incident.

6/1	West River Rd.	Suspicious Vehicle	Deputies located a vehicle parked on the marina overpass during the late hours of the night. The occupants were located nearby and advised.
6/2	Grand Island Blvd.	Traffic Arrest	Following a traffic stop, Deputies arrested 22 y/o Shane Bennett of Grand Island for Aggravated Unlicensed Operation 3 <sup>rd</sup> Degree (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently suspended. Bennett was issued an appearance ticket returnable to the Town of Grand Island Court.
6/2	South State Pkwy.	Suspicious Person with Vehicle	The complainant states that 2 vans were driving on South State Pkwy. and the drivers had masks over their faces. Deputies checked the area but were unable to locate the vehicles by the description given.
6/2	Love Rd.	Traffic Complaint	The complainant states that a vehicle was swerving all over the roadway. Deputies checked the area but were unable to locate the vehicles by the description given.
6/3	Stony Point Rd.	Disorderly Person	The complainant states that a large group of cars drove by early in the morning and were honking their horns excessively. Deputies checked the area but were unable to locate the vehicles by the description given.
6/3	Grand Island Blvd.	Traffic Arrest	Following a traffic stop, Deputies arrested 19 y/o Alyssa Fasciano of Niagara Falls for Aggravated Unlicensed Operation 2 <sup>nd</sup> Degree (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently suspended. Fasciano was issued an appearance ticket returnable to the Town of Grand Island Court.
6/3	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of Tops. No injuries were reported.
6/3	I-190	Traffic / Warrant Arrest	Following a traffic stop, Deputies arrested 37 y/o Luis Figueroa of Buffalo for Aggravated Unlicensed Operation 3 <sup>rd</sup> Degree (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently suspended. Figueroa was also found to have a warrant from the Town of Tonawanda. Figueroa was transferred to the custody of the Town of Tonawanda Police Department.
