The Erie County Sheriff's Office responded to 227 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

6/28	Fix Rd.	Loud Music	The complainant states that loud music was coming from a nearby residence during the late hours of the night. Deputies located the source of the music and advised the homeowners.
6/28	Love Rd.	Customer Trouble	Employees of Say Cheese state that two patrons were refusing to pay their bar bill. Deputies spoke to all parties involved, and the patrons paid the bill then left without incident.

6/30	Baseline Rd.	Traffic Control Device	Deputies located a traffic light that was not functioning at the intersection of Bedell Rd. The Grand Island High Department was notified.
6/30	Fairview Ct.	Fraud	The complainant states that she filed her tax return and then received notification from the IRS that the return was already submitted.
6/30	Pin Oak Cr.	Parking Complaint	The complainant states that a vehicle was parked unlawfully on a neighbor's property. Deputies checked and determined the complaint to be unfounded.

Traffic Arrest	Following an investigation of an incident stemming from a traffic stop several weeks prior, Deputies arrested 47 y/o William Patterson of Grand Island for Obstruction of Governmental Administration 2 nd Degree (Class A Misdemeanor) and several traffic infractions after Patterson fled on foot from Deputies who were attempting to conduct a traffic stop on his vehicle for a speeding violation. Patterson was issued an appearance ticket returnable to the Town of Grand Island Court.
6/30	Jenell Dr.	Suspicious Person with Vehicle	The complainant states that a vehicle was racing around the neighborhood several times. Deputies located the vehicle and advised the driver.
7/1	Glen Avon Rd.	Suspicious Person with Vehicle	The complainant states that a vehicle was parked in a nearby driveway and the female driver was sleeping behind the wheel during the late hours of the night. Deputies located the vehicle and advised the female driver.
7/1	Grand Island Blvd.	Animal Complaint	The complainant states that an injured deer was wandering around behind Tops Markets. Deputies checked the area but were unable to locate any injured deer.
7/1	Whitehaven Rd.	Larceny	The complainant states that while he was paying for gas at a local business, an unknown person(s) stole a laptop from his unlocked vehicle. Investigation Ongoing.
7/1	Whitehaven Rd.	Larceny	The complainant states that sometime during the night, an unknown person(s) stole various items from her unlocked vehicle.
7/1	Bedell Rd.	Wires Down	Deputies responded to a report of wires down and laying in the roadway. The wires were determined to be a phone line and the proper authority was notified.
7/1	East River Rd.	Grass Fire	The complainant states that he observed a small brush fire in the area of the South Grand Island Bridge. Deputies checked the area and determined the complaint to be unfounded.
7/1	Baseline Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
7/1	Whitehaven Rd.	Suspicious Vehicle	The complainant states that 2 vehicles were sitting at the corner of 2 nd St. Deputies checked the area but were unable to locate the vehicles by the description given.
7/1	Woodlee La.	Animal Loose	The complainant states that 2 large dogs were running loose in the neighborhood. The Dog Control Officer was

			notified.
7/1	I-190	Grass Fire	The complainant states that a small amount of grass appeared to be burning in the area of the thruway. The Grand Island Fire Department was notified and extinguished brush fire.
7/1	Grand Island Blvd.	Larceny	The complainant states that while she was at Fantasy Island she left her backpack unattended for a brief moment and when she returned the backpack was gone. In searching the nearby area the backpack was located in a garbage can but several items were reported stolen.
7/1	Islewoods St.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
7/1	Havenwood La.	Suspicious Incident	The complainant states he believes he was being targeted in a Facebook scam as he was contacted by a person purporting to be a friend, and wanting to borrow a small sum of money. The complainant was advised.
7/1	Park La.	Suspicious Incident	The complainant states that a lamp post was knocked over and wires from inside were exposed. National Grid was notified.
7/1	Baseline Rd.	Suspicious Person	The complainant states that a female subject was sitting on the side of the road and appeared to be watching traffic. Deputies checked the area but were unable to locate the female by the description given.
7/2	South La.	Criminal Mischief	The complainant states that sometime during the night, an unknown person(s) egged several houses and vehicles in the neighborhood.
7/2	Park Pl.	Reckless Operation	The complainant states that 2 vehicles were racing through the neighborhood. Deputies spoke to numerous neighbors in the area who stated they did not see any racing vehicles.
7/2	South State Pkwy.	Reckless Operation	The complainant states that a vehicle was traveling in the wrong lane of traffic on South State Pkwy. Deputies checked the area but were unable to locate any vehicles by the description given.
7/2	Whitehaven Rd.	Marijuana Possession	While conducting a vessel stop at River Oaks Marina, Deputies assigned to the Marine Unit arrested 27 y/o Greg Heinz of Buffalo and 26 y/o Rachel Tabone of Buffalo for Unlawful Possession of Marijuana (Violation). Both subjects were issued an appearance ticket returnable to the Town of Grand Island Court.
7/2	Grand Island Blvd.	Loud Music	The complainant states that loud music was coming from a nearby apartment in his complex during the late evening hours. Deputies located the source of the music and advised the occupants.
7/3	Grand Island Blvd.	Deer Struck	Deputies responded to a report of an injured deer that was possibly struck by an unknown vehicle. Prior to the arrival of Patrol, the deer wandered back into the woods.
7/3	Bedell Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in a parking lot. No injuries were reported.
7/3	Baseline Rd.	Animal Loose	The complainant states that several chickens were running loose in the parking lot of an apartment complex.
7/3	South State Pkwy.	Animal Complaint	The complainant states that a coyote chased after him

			while he was on the bike path. Deputies checked the area but were unable to locate the animal.
7/3	Baseline Rd.	Pistol Permit Investigation	Deputies conducted a background check of a person who applied for a pistol permit.
7/3	Enola Rd.	Fireworks Possession / Marijuana Possession	The complainant states that 2 male subjects were setting off fireworks nearby. Deputies arrived on scene and located 2 subjects matching the description. Their investigation led to the arrest of 2 Juvenile Offenders for Unlawful Possession of Marijuana (Violation), Possession of Alcohol by Persons Under 21 (Violation) and Possession of Fireworks (Violation). The Offenders were issued appearance tickets returnable to the Town of Grand Island Court.
7/3	Whitehaven Rd.	Disturbance	The complainant states that 2 subjects were fighting in the parking lot of Noco. Deputies located the 2 subjects who admitted having a dispute but neither party wished to pursue any charges. The subjects were advised and left without incident.
7/4	Carl Rd.	Loud Music	The complainant states that loud music was coming from somewhere nearby during the late hours of the night. Deputies located the source of the music and advised the homeowners.
7/4	East River Rd.	Fireworks Use	The complainant states that loud fireworks were being set off near the area of Grass Island. Deputies checked and determined the complaint to be unfounded.
7/4	Marlin Ct.	Animal Loose	The complainant states she found a dog running loose in the neighborhood. The Dog Control Officer was notified.
7/4	Bedell Rd.	Reckless Operation	The complainant states that a vehicle was swerving all over the road. Deputies checked the area but were unable to locate the vehicle by the description given.
7/4	Timberlink Dr.	Animal Loose	The complainant states that a dog was running loose in the neighborhood. The Dog Control Officer was notified.
7/4	Meadow La.	Fireworks Use	The complainant states that loud fireworks were being set off at a nearby residence. Deputies checked the area but observed no fireworks being used.
7/4	Ransom Rd.	Fireworks Use	The complainant states that fireworks were being used near the area of the High School. Deputies checked the area but observed no fireworks being used.
