



Erie County Sheriffs Office Media Release Summary

The Erie County Sheriff's Office responded to 212 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
6/29	Baseline Rd.	Accident Injury	Deputies responded to a report of a bicyclist that had been struck by a motor vehicle. The bicyclist sustained seemingly non-life threatening injuries and was transported to a local area hospital. The driver of the vehicle was issued traffic tickets returnable to the Town of Grand Island Court.
6/29	Stony Point Rd.	Narcotics/Warrant Arrest	Following a traffic stop, Deputies arrested 29 y/o Kristyn Dowd of Grand Island after a check of her license showed she had an outstanding Bench Warrant from the City of Buffalo. After searching Dowd's vehicle, Deputies located a small amount of narcotics inside. Dowd was charged with Criminal Possession of a Controlled Substance 7 th Degree (Class A Misdemeanor), and Criminally Possessing a Hypodermic Instrument (Class A Misdemeanor). Dowd was transported to the Erie County Holding Center pending arraignment in the Town of Grand Island Court.
6/29	Revere Rd.	Residential Burglary	The complainant states that a known individual entered her residence and stole various items while inside. Erie County Sheriffs Detective's investigation led to the arrest of a Juvenile Offender for Burglary 2 nd Degree (Class C Felony), Criminal Possession of Stolen Property 5 th Degree (Class A Misdemeanor), and Petit Larceny (Class A Misdemeanor). The Juvenile Offender was transported to the Erie County Holding Center pending his arraignment in the Town of Grand Island Court.
6/29	Beaver Island State Park	Suspicious Person with Vehicle	Deputies located a suspicious vehicle parked in Beaver Island State Park occupied by several individuals. The subjects were advised and left the park without incident.
6/29	Bedell Rd.	Endangering the Welfare of a Child	The complainant states that 2 small children were walking around the Country Glen Apartment complex with no parent around. Deputy's investigation led to the arrest of 30 y/o Debra Daigle of Grand Island. Daigle is

			charged with 2 counts of Endangering the Welfare of a Child (Class A Misdemeanor) and was transported to the Erie County Holding Center in lieu of \$500 bail. The children were turned over to the custody of another family member.
6/29	East River Rd.	Loud Music	The complainant states that loud music was coming from nearby residence during the late hours of the night. Deputies spoke to the occupants and advised them.
6/30	Havenwood La.	Suspicious Person with Vehicle	The complainant states that a suspicious vehicle was parked outside of a home that was still in the construction phase and appeared to be occupied. Deputies located the vehicle and advised the driver.
6/30	Town Hall Te.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
6/30	Town Hall Te.	Youth Activity	The complainant states that kids in the area were being very loud and seemed to be destroying some type of cardboard box. Deputies located the youths who were playing and advised them to keep the noise down.
6/30	West River Rd.	Fireworks Use	The complainant states that fireworks were being set off somewhere in the area. Deputies checked the area and determined the complaint to be unfounded.
7/1	Hidden Oak Ct.	Suspicious Incident	The complainant states that 2 males were outside of her residence and were mowing her lawn. The complainant stated she did not hire anyone to perform such work. Deputies spoke to the males who were working for a landscaping company and came to the wrong address.
7/1	Grand Island Blvd.	Suspicious Person	The complainant states that a person had pitched a tent near the information center. Deputies spoke to the individuals who stated they were hiking through the area.
7/1	Cox Rd.	Suspicious Incident	The complainant states that sometime in recent hours an unknown person stole a bicycle from her property. Prior to the arrival of Patrol, the complainant called back and stated that her daughter's friend had the bicycle and it was not stolen.
7/1	Baseline Rd.	Reckless Operation	The complainant states that a pickup truck was swerving in and out of traffic while driving down the road. Deputies checked the area and determined the complaint to be unfounded.
7/1	Love Rd.	Accident Injury	Deputies responded to a report of a 2 car motor vehicle accident. One driver was transported to a local area hospital with seemingly non-life threatening injuries.
7/2	Bedell Rd.	Youth Activity	The complainant states that several youths were being loud in the parking lot of his apartment complex during the late hours of the night. Deputies located the youths and advised them.
7/2	Whitehaven Rd.	Property Found	Deputies located an electric shopping cart on the side of the road that belonged to Tops Markets. The cart was returned.
7/2	Wallace Dr.	Residential Fire	Deputies assisted Grand Island Fire Department with a report of an electrical fire. Damage was minimal and no injuries were reported.
7/2	Alvin Rd.	Larceny	Employees of Fucillo Toyota state that sometime during

			the night, an unknown person(s) stole various items from the sales lot. Investigation Ongoing.
7/2	Love Rd.	Suspicious Person	The complainant states he observed a male subject lying on top of his minivan roof and was unsure if the person was alive or dead. Deputies located the subject, who appeared in good health, and advised him.
7/2	Long Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
7/3	Havenwood La.	Loud Music	The complainant states that loud music was coming from a yard of a nearby residence during the late hours of the night. Deputies advised the subjects to turn down the music.
7/3	Adel La.	Loud Music	Complainant states that several people were outside of a residence and talking very loudly during the late hours of the night. Deputies checked the area and determined the complaint to be unfounded.
7/3	I-190	Road Obstruction	Deputies located a ladder in a lane of traffic on the I-190. The obstruction was removed.
7/3	Alt Blvd.	Suspicious Incident	The complainant states that a male subject called her residence from a blocked telephone number and stated he was from technical services. The male said that the complainant's computer was not properly working but when confronted with questions by the complainant the subject hung up.
7/3	Wallace Dr.	Larceny	The complainant states that sometime during the night, an unknown person(s) stole the license plate from his motorcycle.
7/4	Staley Rd.	Suspicious Incident	The complainant states that it appeared a door to a seemingly vacant house was open and was unsure if anyone was inside. Deputies made contact with the homeowner of the residence who reported no problems.
7/4	Bedell Rd.	Suspicious Incident	The complainant states that a vehicle was parked on the grass at Veterans Park and a nearby container door was open. Deputies checked and determined the container door to be an oversight. The owner of the vehicle was contacted and the vehicle was moved.
7/4	Baseline Rd.	Parking Violation	The complainant states that several vehicles were parked illegally behind Tops Markets and others in the front in the fire lane. Deputies issued 3 parking tickets.
7/4	Carl Rd.	Accident Hit & Run	Deputies responded to a report of a 2 car motor vehicle accident. Prior to Patrols arrival, one of the vehicles fled the scene. No injuries were reported and the investigation is ongoing.
7/4	Colonial Dr. West	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
7/4	Baseline Rd.	Loud Music	The complainant states that several people were outside of her residence screaming for several hours. Deputies located the subjects and advised them.
7/4	Oakridge Dr.	Loud Music	The complainant states that loud music was coming from a nearby residence. Deputies located the residence and advised the occupants.
7/5	West River Rd.	Suspicious Incident	The complainant states that she went to the river overlook near Whitehaven Rd. and noticed a suspicious

			looking male staring at her. The complainant became uncomfortable and left the area. The complainant then went to the river overlook near Fix Rd. and after several minutes the same male approached her and asked if her name was Amy. The complainant responded no and left the area to return home. The complainant described the male subject as in his 50's with dark hair and dark sunglasses. He drove a black colored vehicle. The complainant had no further information to provide about the incident.
