The Erie County Sheriff's Office responded to 196 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

7/13	Whitehaven Rd.	Disorderly Person	An employee of Byblos Niagara Resort and Spa states that numerous subjects were being disorderly and running through the hotel during the late hours of the night. Deputies located the room in question and advised the subjects.

Bahleda was issued an appearance ticket returnable to the Town of Grand Island Court.
