The Erie County Sheriff's Office responded to 219 calls the week of this report. Below is a sampling of the noteworthy incidents in **Grand Island**.

Date	Type	Street	Narrative
7/18	Disturbance Other	Elmwood Rd	Deputies responded to a female calling stating that her husband hit her. Deputies interviewed both parties and their stories changed several times. Appeared to be a verbal argument of sorts, all parties advised.
7/21	Refer to Patrol	Mighty Taco	Deputies were called to the back of Mighty Taco for an unruly male harassing employee's. Male was located by deputies and removed from the area by request of management.
7/22	Domestic Trouble	Veteran's Park	Deputies spoke with a female and her mother in regards to a domestic situation. Daughter was assaulted by boyfriend in her car at the park last night. Boyfriend was located at his storage facility and arrested. Subject was transported to the ECHC until arraignment. Vehicle was returned to the family.
7/22	Larceny from Vehicle	Just Pizza GI	Deputies responded to the parking lot of Just Pizza as an employee's bag was stolen from her vehicle. Deputies investigated at scene and are collecting camera footage. Report taken.
7/22	Disturbance	Town Hall Terrace	State Police were dispatched to a disturbance called in by third party trying to get her daughter out of a hostile relationship. State police helped her get her belongings from the residence as the male half seemed a little agitated with the situation.
7/23	Suspicious Person	Enola Rd.	Deputies responded to Enola Rd. for suspicious person's going through vehicles. Ring camera shows males checking car doors and getting into a small white SUV and into a neighbor's car. Deputies canvassed the area and later in the evening other related calls came in regarding vehicle's entered
7/23	Larceny from Vehicle's	Spicer Creek, Riverwoods Dr., and Stonypoint Rd.	Deputies received several calls in the morning related to the males who went through cars overnight. One person had their debit card and work bag taken and another had their wallet taken. One vehicle owner had his 9mm pistol taken form his vehicle. Please remember to lock your doors and secure your valuables at night.
7/23	UUMV	Marjorie Dr.	Deputies were notified in the morning that someone stole their Dodge Charger from their driveway overnight. The vehicle had no plates on it as it hasn't driven in some time due to damage. Unfortunately the key fob was in it and it still ran fine. Deputies believe the same males from last night took this vehicle as well.

7/23	Accident/DWI Drugs	McDonalds	State Police and Deputies responded to a truck that crashed into the sign at McDonalds with an unconscious driver at the wheel. Driver was found barely breathing and treated by EMS. Driver, was found to be overdosing from drugs by state police. He was transported to ECMC by ambulance and state police followed to administer tests and draw blood. Driver was arrested for DWI
7/24	Mental	Waterford Park	drugs and released on an appearance ticket.  Deputies responded to a male jumping in off the dock at Turner's Bar. Deputies arrived to find the male in knee deep water. He was pulled out and wife advised us that he was trying to kill himself by jumping in the river. Subject was evaluated and transported to the ECMC for evaluation of MHL 9.41
