The Erie County Sheriff's Office responded to 194 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

| 6/25 | Bedell Rd. | Residential Fire | Deputies assisted the Grand Island Fire Department with a report of a fire at the Country Glen Apartments. The fire was contained to a balcony. No injuries were reported. |
| 6/25 | East River Rd. | Traffic Complaint | The complainant states that a young child was riding a motorized scooter up and down the street. Deputies checked the area but were unable to locate the youth. |
| 6/25 | Grand Island Blvd. | Suspicious Person | The complainant states that a male subject was in the Fantasy Island parking lot trying to open car doors. Deputies checked the lot but were unable to locate the male by the description given. |
| 6/25 | Grand Island Blvd. | Traffic Arrest | Following a traffic stop, Deputies arrested 57 y/o John Sadler of Niagara Falls for Aggravated Unlicensed Operation 3 rd Degree (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently suspended. Sadler was issued an appearance ticket returnable to the Town of Grand Island Court. |
| 6/25 | Garden Pkwy. | Suspicious Person with Vehicle | The complainant states that a vehicle was parked in front of her residence and the occupants asked her about her son before fleeing the area. Deputies checked the area but were unable to locate the vehicle by the description given. |
| 6/25 | Grand Island Blvd. | Traffic Arrest / Marijuana Possession | Following a traffic stop, Deputies arrested 32 y/o Andrew Siekierski of Grand Island for Aggravated Unlicensed Operation 3 rd Degree (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently suspended. | 6/26 | Love Rd. | Traffic Control Device | Deputies observed the traffic light at Baseline Rd. not working properly. NITTEC was notified. |
| 6/26 | Love Rd. | Traffic Complaint | The complainant states that a vehicle was driving recklessly and running other cars off the road. Deputies checked the area but were unable to locate the vehicle by the description given. |
| 6/26 | Love Rd. | Traffic Arrest | Following a traffic stop, Deputies arrested 43 y/o George Newman of Buffalo for Operating a Motor Vehicle with a Suspended Registration (Misdemeanor) and other traffic infractions after a DMV check showed his registration was currently suspended. Newman was issued an appearance ticket returnable to the Town of Grand Island Court. |
| 6/26 | Love Rd. | Fireworks Use | The complainant states that neighbors were using fireworks for approximately an hour. Deputies located the source of the fireworks and advised the occupants. |
| 6/27 | Grand Island Blvd. | Suspicious Incident | The complainant states that a motorcycle was parked in the Christian Assembly church parking lot during the late hours of the night and no one was around. Deputies checked the premise but found nothing out of order. The owner could not be located. |

| 6/29 | Sturbridge La. | Shots Fired | The complainant states he heard several gun shots in the area and did not think they were coming from the gun club. Deputies checked the area but were unable to hear any gun shots. |
| 6/29 | Grand Island Blvd. | Larceny | The complainant states that while she was at Fantasy Island an unknown person(s) stole her unattended cell phone. |
| 6/29 | Baseline Rd. | Suspicious Person | The complainant states that a male subject was walking around the Emmanuel United Methodist Church claiming he was looking for snakes. After confronting him, the subject got into a vehicle and left the area. |
| 6/29 | Stony Point Rd. | Welfare Check | Deputies responded to a report of a 911 hang up call. Deputies spoke to the occupants and determined the call to be a misdial. |
| 6/30 | Staley Rd. | Marijuana Possession | Following a traffic stop, Deputies arrested 33 y/o Allen Clemons of Buffalo for Unlawful Possession of Marijuana (Violation) and a traffic infraction. Clemons was issued an appearance ticket returnable to the Town of Grand Island Court. |
| 6/30 | Huth Rd. | Suspicious Incident | The complainant states that it appears an unknown person(s) started a fire in the mulch at the Huth Rd. Elementary School playground. No damage was done to the playground equipment. |
| 6/30 | South State Pkwy. | Assault | The complainant states she witnessed a fight while driving and one of the combatants left the scene. Deputies investigation led to the arrest of 18 y/o Travis Mikulski for Assault 3 rd Degree (Class A Misdemeanor). Deputies investigation of that incident led to the arrest of the male subject from 7-11, 18 y/o Travis Mikulski of Grand Island for Burglary 3 rd Degree (Class D Felony), Grand Larceny 3 rd Degree (Class D Felony), Criminal Possession of Stolen Property 4 th Degree (Class E Felony) and Criminal Mischief 4 th Degree (Class A Misdemeanor). Deputies recovered property stolen from the Burglary. Mikulski was transported to the Erie County Holding Center pending his arraignment in the Town of Grand Island Court. |
