



Erie County Sheriffs Office Media Release Summary

Dates: 8/4/2012 to 8/10/2012

The Erie County Sheriff's Office responded to 176 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
8/4	Pleasant Tr.	Loud Music	Complainant states that loud music was coming from a house in the neighborhood late at night. Deputies located the house and advised the occupants to turn the music down.
8/4	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
8/4	East River Rd.	Pistol Permit Investigation	Deputies conducted a background check of an individual who applied for a pistol permit.
8/4	Sandpiper La.	Fireworks Use	Complainant states that someone was using fireworks in the area. Deputies checked but were unable to locate anyone using fireworks.
8/4	Grand Island Blvd.	Larceny	Complainant states that while he was in Fantasy Island, an unknown person(s) entered his vehicle and attempted to steal items. At the time of this report, no items were listed as missing.
8/4	West River Rd.	Reckless Operation	Complainant states that a vehicle was speeding down West River Rd. Deputies checked the area but were unable to locate the vehicle.
8/4	Queens Dr.	Accident Injury	Deputies responded to a report of a 1 car motor vehicle accident. 1 person was transported to a local hospital with seemingly minor injuries.
8/4	First St.	Suspicious Incident	Complainant states she thought she heard a person attempting to break into her residence. Deputies checked the area but were unable to locate any subjects. No damage to the residence was observed.
8/5	East River Rd.	Residential Burglary	Complainant states that sometime in recent days an unknown person(s) broke into their residence and stole a sum of money. The suspects were able to gain entry by prying open a window. Investigation Ongoing.
8/5	Grand Island Blvd.	Reckless Operation	Complainant states a vehicle was swerving all over the road. Deputies checked the area but were unable to locate the vehicle.
8/5	Bedell Rd.	ATV Operation	Complainant states that numerous ATV's were operating in Veterans Park. Deputies checked the area but were unable to locate the ATV's

8/5	Bedell Rd.	Suspicious Person	Complainant states that a suspicious male subject had approached some young females while in Veterans Park. Deputies located the subject, who stated he was in the park watching his son's soccer game. The subject was advised.
8/5	Sheree Dr.	Suspicious Incident	Complainant states that a group of youths seemed to be attempting to break into a residence. Deputies were able to determine that the subjects were friends with a male who lived in the house. The subjects were advised.
8/6	West River Rd.	Attempted Break In	Complainant states that he was awoken at night by sounds coming from the front of his residence. The complainant saw someone with a flashlight near the house, and scared off the subject(s). When he checked outside he noticed a screen door had been sliced and a window was pushed in. Deputies checked the area but were unable to locate any subjects. Investigation Ongoing.
8/6	East River Rd.	Suspicious Incident	Complainant states that sometime during the night, an unknown person(s) put feces on his vehicle. No damage was observed.
8/6	Baseline Rd.	Accident Injury	Deputies responded to a report of a 2 car motor vehicle accident. Upon arrival Deputies found 1 unconscious female who was trapped in her vehicle. Grand Island Fire Department responded to extricate the victim. The female driver was transported to Erie County Medical Center and was listed in critical condition. The other driver was transported to a local hospital with seemingly minor injuries. Erie County Sheriffs Accident Investigation Unit responded and the cause of the crash is under investigation.
8/6	Riverdale Dr.	Animal Complaint	Complainant states that a dog in the neighborhood appeared to be in distress. Deputies checked the area but were unable to locate the dog. The Dog Control Officer was notified.
8/6	Whitehaven Rd.	Animal Complaint	Complainant states a dog was running loose in the area. Deputies checked but were unable to locate the dog. The Dog Control Officer was notified.
8/6	Brandywine Dr.	Suspicious Vehicle	Complainant states that a suspicious vehicle was parked in front of his residence late at night and appeared to be occupied. Deputies located the vehicle and spoke to the driver who stated she was waiting for a friend. The subject was advised.
8/6	Bedell Rd.	Suspicious Incident	Complainant states that he came home from work to find 2 bicycles missing from his yard. Deputies were able to locate the bicycles in nearby yards.
8/7	Baseline Rd.	Drunk	Complainant states a female was stumbling down the road, possibly intoxicated. Deputies located the female and transported her back to her residence.
8/7	Stony Point Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
8/7	Love Rd.	Larceny	Complainant states that sometime during recent hours, an unknown person(s) stole a gas grill from their yard.
8/7	Baseline Rd.	Accident Injury	Deputies responded to a report of a 2 car motor vehicle

			accident involving a motorcycle. The passenger of the motorcycle was transported to a local hospital with seemingly minor injuries.
8/7	West River Pkwy	Road Obstruction	Complainant states that a muffler was in the roadway on West River Pkwy. Deputies removed the muffler from the road.
8/7	Winter Rd.	Property Found	Complainant states that a possible stolen bicycle was sitting next to a dumpster for about a week. Deputies brought the bicycle to the Grand Island Substation.
8/7	Bishops Gate Rd.	ATV Operation	Complainant states that ATV's were driving in the road and on private property. Deputies located the ATV's and advised the operators.
8/7	Grand Island Blvd.	Suspicious Person	Complainant states that a suspicious male was walking around construction equipment near Tops. Deputies located the male, who was an employee, that was repairing the construction vehicles.
8/7	Whitehaven Rd.	Suspicious Vehicle	Deputies located an unoccupied vehicle parked in the WUTV Fox parking lot. No subjects were around the vehicle and no damage was observed.
8/8	Elsie La. Lasalle Ave. Red Jacket Rd.	Larceny	Complainant that resides on Elsie Lane stated that he found the dome light on in his vehicle and items were missing. The complainant stated the incident occurred within the last 15 minutes. Deputies checked the area and were able to find 4 Juvenile Offenders (2 residing in Grand Island and 2 residing in Buffalo) that were responsible for multiple reports of larcenies in the neighborhood. Deputies charged each of the Juvenile Offenders with Conspiracy 6 th Degree (Class B Misdemeanor), 7 counts of Criminal Possession of Stolen Property 5 th Degree (Class A Misdemeanor) and 7 counts of Petit Larceny (Class A Misdemeanor). 2 of the Juvenile Offenders (Ages 17) were transported to the Erie County Holding Center pending arraignment in Town of Grand Island Court. The other 2 Juvenile Offenders (Ages 15 and 14) were issued appearance tickets returnable to Erie County Family Court and released to the custody of their parents.
8/8	Greenway Rd.	Marijuana Arrest	Complainant stated that a suspicious vehicle was parked in front of his residence late at night. Deputies located the vehicle with 4 occupants inside. Their investigation led to the arrest of 2 Juvenile Offenders for Unlawful Possession of Marijuana (Violation). The Juvenile Offenders were issued appearance tickets returnable to Town of Grand Island Court.
8/8	Baseline Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
8/8	East River Rd.	Reckless Operation	Complainant states a vehicle was running stop signs on East River Rd. Deputies checked the area but were unable to locate the vehicle.
8/8	Beaver Island State Park	Disorderly Person	Deputies were flagged down by a complainant regarding disorderly subjects in the park. Deputies located the subjects and advised them.
8/9	Grand Island Blvd.	Suspicious Person	Complainant states that a subject was sleeping in his car

			in the Tops parking lot. Deputies located the subject and advised him. The subject left without incident.
8/9	Gregory Pl.	Criminal Mischief	Complainant states that sometime during the night, an unknown person(s) keyed his vehicle. Investigation Ongoing.
8/9	I-190	Motorist Broke Down	Deputies assisted a motorist whose vehicle had broken down.
8/9	West River Rd.	Loud Music	Complainant states that loud music was coming from a party in the neighborhood. Deputies located the party and advised the subjects.
8/10	South State Pkwy.	Accident Injury	Deputies responded to a report of a 2 car motor vehicle accident involving a semi-truck. Multiple people were transported to area hospitals with serious injuries. The Erie County Sheriffs Accident Investigation Unit responded to the scene and the cause of the crash is under investigation.
8/10	Ferry Rd.	Open Door	Complainant states that an open door was seen at a business in the area. Deputies were able to secure the door and notified the owner of the incident.
