

Erie County Sheriffs Office Media Release Summary

Dates: 8/11/2012 to 8/17/2012

The Erie County Sheriff's Office responded to 153 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

8/11	Ward Park Rd.	Criminal Mischief	Complainant states that sometime during the night, an unknown person(s) damaged plants in his garden.
8/11	South State Pkwy.	Suspicious Vehicle	Complainant states that a suspicious vehicle was parked on the side of the road. Deputies were able to locate the vehicle and advised the driver.
8/11	Stony Point Rd.	Warrant Arrest	Deputies arrested a Juvenile Offender on 2 outstanding warrants. The warrants were from Town of Grand Island and City of Tonawanda. The Juvenile Offender was transported to the Erie County Holding Center.
8/12	Hazelwood La.	Suspicious Person	Complainant states that 2 subjects in masks were running through the neighborhood. Deputies located the subjects who were playing a prank on friends at a party. The subjects were advised.
8/12	Baseline Rd.	Suspicious Incident	Complainant states that she heard someone attempting to break into her residence. Deputies located the subject, who was a family member that came home early from a friend's house.
8/12	Huth Rd.	Criminal Mischief	Complainant states that sometime during the night, an unknown person(s) threw eggs at his car. No damage was reported.
8/12	East Park Rd.	Reckless Operation	Complainant states a vehicle was speeding through the neighborhood. Deputies located the vehicle and advised the driver.
8/12	Stony Point Rd.	Loud Music	Complainant states that loud music was coming from a residence in the area. Deputies located the source of the music and advised the homeowner to turn the music down.
8/12	Oakridge Dr.	Suspicious Person	Complainant states that a younger male subject was skateboarding through the neighborhood during the late evening hours. Deputies checked the area but were unable to locate the subject.
8/12	Town Hall Terr.	Loud Music	Complainant states that loud music was coming from an apartment in the complex. Deputies located the apartment and advised the subjects to turn their TV down

8/12	Baseline Rd.	Suspicious Vehicle	Complainant states that a vehicle was parked behind Sidway Elementary School late at night. Deputies located 2 subjects with the vehicle and advised them. The subjects left without incident. No damage was observed.
8/13	Grand Island Blvd.	Drunk Driving	Following a traffic stop and subsequent investigation, Deputies arrested 32 y/o Darlene Golden of Grand Island for Driving While Intoxicated and other traffic violations. Golden refused to submit a sample of her breathe for chemical analysis. Golden was issued an appearance ticket returnable to Town of Grand Island Court and released to a sober 3 rd party.
8/13	Grand Island Blvd.	Larceny	Complainant states that while she was working at Walgreens her wallet was stolen. Patrol was able to ascertain a possible suspect involved and an investigation into the manner is ongoing.
8/13	Whitehaven Road	Animal Loose	Complainant states a large dog was running loose in the area. Deputies checked but were unable to locate the dog. The Dog Control Officer was notified.
8/13	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
8/13	Grand Island Blvd.	Property Found	An employee at Tops states that a wallet was found in the parking lot. Deputies were able to contact the owner and the wallet was returned.
8/13	East River Rd.	Youth Activity	Complainant states that youths were seen jumping into the Niagara River from Fisherman's Landing. Deputies checked the area but were unable to locate the youths.
8/13	Staley Rd.	Suspicious Person	Complainant states that a couple suspicious persons were in their driveway looking into vehicles. Deputies checked the area but were unable to locate any subjects. No larcenies or damage were reported.
8/13	Woodlee La.	Suspicious Person	Complainant states that unknown person(s) were knocking on her door late at night and then running away. Deputies checked the area but were unable to locate any subjects.
8/13	Broadway	Youth Activity	Complainant states that youths were throwing branches into the street late at night. Deputies located the youths, who cleaned up the branches.
8/14	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
8/14	Town Hall Te.	Drunk Driving	Following a traffic stop and subsequent investigation, Deputies arrested 47 y/o Marylynn Major of Grand Island for Driving While Intoxicated. Major submitted to a chemical analysis of breathe and registered a .19% B.A.C. (more than double the legal limit). Major was also charged with Aggravated Driving While Intoxicated due to the elevated readings. Major was issued an appearance ticket returnable to Town of Grand Island Court and released to a sober 3 rd party.
8/14	Pleasant Trail Rd.	Suspicious Person	Complainant states that a suspicious male was riding a bicycle in the neighborhood and appeared to checking out houses. Deputies checked the area but were unable to locate the subject.

8/14	Grand Island Blvd.	Warrant Arrest	Following an unrelated complaint, Deputies arrested 31 y/o Venice Cambell of Buffalo after a check showed she had an outstanding Arrest Warrant issued in the City of Buffalo. Cambell was turned over to the custody of the Buffalo Police Department.
8/15	Long Rd.	Loud Music	Complainant states that loud music was coming from a residence in the neighborhood. Deputies checked but were unable to locate any loud music in the area.
8/15	Colonial Dr. East	ATV Operation	Complainant states that an ATV was riding on private property and became stuck. Deputies checked the area but were unable to locate the ATV.
8/15	Baseline Rd.	Accident Injury	Deputies responded to a report of a 3 car motor vehicle accident. Multiple victims were transported to local hospitals with serious injuries.
8/15	East River Rd.	Property Found	Complainant states that he found a wallet in the roadway. Deputies were unable to contact the owner and are waiting for the wallet to be claimed.
8/15	Alt Blvd.	Reckless Operation	Complainant states that a vehicle was doing donuts in a parking lot and cause minor damage to some property.
8/15	Whitehaven Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies were able to make contact with the homeowner and determined the call was a misdial.
8/15	Ransom Rd.	Suspicious Incident	Complainant states a vehicle was parked near an open window at Grand Island High School. Deputies located the owner who was a teacher at the school.
8/15	East River Rd.	Suspicious Vehicle	Deputies located a suspicious vehicle parked underneath the South Grand Island Bridge near some construction equipment. No subjects were around the vehicle and no damage was observed
8/15	Grand Island Blvd.	Reckless Operation	Complainant states a vehicle was driving erratically on Grand Island Blvd. Deputies checked the area but were unable to locate the vehicle.
8/15	Bedell Rd.	ATV Operation	Complainant states that a dirt bike was speeding through Veterans Park. Deputies checked the area but were unable to determine who the operator was.
8/15	East River Rd.	Reckless Operation	Complainant states a vehicle was driving erratically on East River Rd. Deputies checked the area but were unable to locate the vehicle.
8/15	Stony Point Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle became disabled.
8/15	Bedell Rd.	Suspicious Vehicle	Deputies located a suspicious vehicle parked in Veterans Park late at night. No subjects were around the vehicle and no damage was observed.
8/16	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
8/17	Bedell Rd.	ATV Operation	Complainant states a dirt bike was operating in Veterans Park and damaging baseball diamonds. Deputies checked the area but were unable to determine the operator of the dirt bike.
8/17	Buckhorn State Park	Property Found	Complainant states that he found a bicycle in the weeds in Buckhorn State Park. Deputies located the bicycle and brought it to the Grand Island Substation to be claimed.

8/17	Settlers Row	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies were able to make contact with the homeowner and determined the call was a misdial.
8/17	East Park Rd.	Youth Activity	Complainant states that youths in the area threw and egg at her vehicle. No damage was observed.
