



Erie County Sheriffs Office Media Release Summary

The Erie County Sheriff's Office responded to 199 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
8/9	East Park Rd.	Suspicious Person	The complainant states he observed a male subject in his backyard during the late hours of the night when he returned home. The subject then fled through neighboring yards on foot. Deputies checked the area but were unable to locate the subject by the description given. Nothing was reported stolen but the subject had unscrewed the light bulb in the security light in the backyard.
8/9	Elmwood Rd.	Animal Loose	The complainant states that a dog that was unleashed chased her as she walked by a residence. The Dog Control Officer was notified.
8/9	Huth Rd.	Suspicious Incident	The complainant states that sometime in recent days, an unknown person(s) had removed screens from windows on the exterior of Huth Rd. Elementary School. It was determined no entry was gained into the building.
8/9	East River Rd.	Larceny	The complainant states that sometime in recent weeks, an unknown person(s) stole a kayak from his yard.
8/9	Ransom Rd.	Pistol Permit Investigation	Deputies conducted a background check of a person who applied for a pistol permit.
8/9	Spicer Creek Run	ATV Operation	The complainant states that a small mini-bike was operating in the roadway. Deputies located the operator at a nearby address and advised him.
8/9	Staley Rd.	Pistol Permit Investigation	Deputies conducted a background check of a person who applied for a pistol permit.
8/9	Staley Rd.	Animal Loose	The complainant states that her dog got loose from the yard sometime in the last several hours. The Dog Control Officer was notified.
8/9	Town Hall Terr.	Noise Complaint	The complainant states that a subject was constantly revving his motorcycle outside of his apartment building. The subject left prior to the arrival of Patrol. The complainant was able to speak with the subject before the subject left the premise and advised him of the noise problem he was creating.
8/10	Staley Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.

8/10	Fareway La.	Disorderly Person	The complainant states that his friend was intoxicated and becoming belligerent. Deputies escorted the subject from the property at the request of the complainant who declined to press charges.
8/10	Grand Island Blvd.	Disturbance	The complainant states that a group of youths in a vehicle were yelling at each other in the parking lot of the Chateau Motor Lodge. Deputies checked the area and determined the complaint was unfounded.
8/10	West River Rd.	Reckless Operation	The complainant states that a motorcycle was traveling down the road at a high rate of speed. Deputies checked the area but were unable to locate the vehicle by the description given.
8/10	Bedell Rd.	Fire Grass	The complainant states that there appeared to be a grass fire in the area of Veterans Park. Deputies checked the area and determined the fire was coming from a nearby residence and was controlled in an enclosed fire pit.
8/10	Stony Point Rd.	Larceny	The complainant states that sometime in recent days an unknown person(s) stole various items from her unlocked vehicle.
8/10	Baseline Rd.	Traffic Arrest	Following a traffic stop, Deputies arrested 25 y/o Brandon Locke for Aggravated Unlicensed Operation 3 rd Degree (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently suspended. Locke was further charged with Criminal Contempt 2 nd Degree (Class A Misdemeanor) after it was discovered that he was violating a Stay Order of Protection by having the protected person inside the vehicle as a passenger. Locke was transported to the Erie County Holding Center pending his arraignment in the Town of Grand Island Court.
8/10	East Park Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
8/10	Whitehaven Rd.	Suspicious Person	The complainant states that he observed people with flashlights near the National Grid power junction during the late evening hours. Deputies checked the area but were unable to locate any persons on the property. No damage was observed.
8/11	Stony Point Rd.	Animal Complaint	The complainant states that there was a large snake in her backyard. The complainant was able to remove the snake and called back to cancel the request for police assistance.
8/11	Love Rd.	Disorderly Person	The complainant states that an intoxicated female subject was inside a vehicle in front of Say Cheese Pizza. The vehicle left prior to the arrival of Patrol. Deputies checked the area but were unable to locate the vehicle.
8/11	Baseline Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
8/11	Havenwood La.	Loud Music	The complainant states that loud music was coming from a nearby residence during the late hours of the night. Deputies located the source of the music and advised the owners.
8/12	Stony Point Rd.	Pistol Permit Investigation	Deputies conducted a background check of a person who applied for a pistol permit.

8/12	Grand Island Blvd.	Larceny	The complainant states that while she was at Fantasy Island, an unknown person(s) stole her purse from a wagon.
8/12	Sheree Dr.	Animal Complaint	The complainant states that a dog was running loose in the neighborhood and was starting fights with other dogs. The Dog Control Officer was notified.
8/12	Ransom Rd.	Larceny	The complainant states that sometime during the night, an unknown person stole various items from her unlocked vehicle.
8/12	Whitehaven Rd.	Fire	Erie County Sheriff's Office Fire Investigation Unit was called to respond to assist Grand Island Fire Department after a fire had broken out in a bathroom building on River Oaks Golf Course.
8/12	Stony Point Rd.	Suspicious Person with Vehicle	The complainant states that several youths were attempting to open the doors to vehicles at the Grand Island Fire Substation. Deputies checked the area but were unable to locate the youths by the description given.
8/13	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of Gui's Lumber. No injuries were reported.
8/13	Second St.	Suspicious Person	The complainant states that several subjects were in her yard and knocking on her windows during the late hours of the night. Deputies checked the area but were unable to locate any persons. No damage was reported.
8/14	Second St.	Suspicious Person	The complainant states he observed a male subject walking around the residence of the above complaint. Deputies determined the male subject had come to assist the original female complainant.
8/15	Whitehaven Rd.	Welfare Check	Deputies responded to a report of several 911 hang up calls at Byblos Niagara Resort & Spa. Deputies determined that the call was a misdial.
8/15	Sunset Dr.	Burglary	The complainant states sometime in the past week, an unknown person(s) entered his unlocked garage and stole an ATV from inside. Investigation Ongoing.
8/15	Grand Island Blvd.	Animal Complaint	The complainant states that a dog was left in a vehicle while in the Tops parking lot and was concerned for the animal's wellbeing. Deputies checked the area but were unable to locate any dogs left in vehicles.
8/15	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of Burger King. No injuries were reported.
8/15	Baseline Rd.	Suspicious Incident	The complainant states that the gate to a construction area around the school was open and was concerned youths might get into the items left inside. Deputies determined the gate was damaged and unable to be closed.
8/15	Park La.	Suspicious Incident	The complainant states that she heard an unknown person ringing her doorbell and pounding on the door seemingly in an attempt to break in during the late evening hours. The subjects left prior to the arrival of Patrol. Deputies checked the area and after speaking with several other neighbors it appeared some youths in

			the area were ringing door bells and running away. No subjects were observed in the area and no damage was reported.
8/15	Baseline Rd.	Loud Music	The complainant stated that loud music was coming from a nearby address. Deputies located the source of the music and advised the home owner.
