



## Erie County Sheriffs Office Media Release Summary

The Erie County Sheriff's Office responded to 185 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

7/25	Fix Rd.	Animal Complaint	The complainant states that several dogs at a nearby residence were barking for hours during the night. Deputies checked but did not locate any barking dogs.
7/25	Whitehaven Rd.	Animal Complaint	An employee of Byblos Niagara Resort & Spa states that a dog was barking in one of the rooms and disturbing other guests during the late hours of the night. Deputies spoke with and advised the occupants of the room.
7/25	Grand Island Blvd.	Customer Trouble	An employee of the Budget Motel states that a patron was screaming at him after a dispute about a refund. The parties were advised and were able to work out the issue.
7/25	Schutt Ct.	Fireworks Use	The complainant states that fireworks were being used in the area behind his residence during the late hours of the night. Deputies checked but did not observe any persons using fireworks.
7/25	Bedell Rd.	Suspicious Person	The complainant states that an intoxicated male was walking in the roadway during the late hours of the night. Deputies checked but were unable to locate the subject by the description given.
7/25	Oakridge Dr.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
7/25	Park Pl.	Suspicious Incident	The complainant states that a male subject stopped near his house and took pictures of the complainant's residence. Deputies located the male subject and advised him.
7/25	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of Tops. No injuries were reported.
7/25	Park Pl.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
7/25	Bedell Rd.	Suspicious Incident	The complainant states that a male subject was driving a motorcycle recklessly on Grand Island Blvd. The male subject followed the complaint to her apartment and took pictures of her vehicle before leaving the area. Deputies checked the area but were unable to locate the motorcycle by the description given.

7/25	Baseline Rd.	Fireworks Use	The complainant states that fireworks were being used at a nearby residence during the late evening hours. Deputies checked but were unable to locate any persons using fireworks.
7/26	East River Rd.	Loud Music	The complainant states that a live band was playing music loudly at Turners Port of Call during the late hours of the night. The employees were advised and the band turned off the music.
7/26	Bedell Rd.	Suspicious Person	The complainant states that a male subject was sleeping in the hallway of her apartment building during the early morning hours. Deputies checked the entire complex but were unable to locate any subjects sleeping in the hallway.
7/26	Grand Island Blvd.	Larceny	Employees of Tops state that a male subject stole various items from the store and was currently at the NFTA bus stop on Grand Island Blvd. Deputies located the subject and their investigation led to the arrest of 59 y/o Ronald Smith Jr. of Clarence for Petit Larceny (Class A Misdemeanor). Smith was issued an appearance ticket returnable to the Town of Grand Island Court.
7/26	Baseline Rd.	Animal Loose	The complainant states that a black lab was running loose in the area. The Dog Control Officer was notified.
7/27	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of Fantasy Island. No injuries were reported.
7/27	Bedell Rd.	Customer Trouble	A taxi driver states that a customer was refusing to pay the fare and also began causing a disturbance. Deputies spoke with all parties and advised them.
7/27	East River Rd.	Larceny	The complainant states that sometime in recent days an unknown person(s) stole a large amount of firewood from his property.
7/27	West River Rd.	Accident PDO / Traffic Arrest	Deputies responded to a report of a 2 car motor vehicle accident. During their investigation Deputies arrested 29 y/o Timothy Mulvey of Grand Island for Aggravated Unlicensed Operation 3 <sup>rd</sup> Degree (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently suspended. Mulvey was issued an appearance ticket returnable to the Town of Grand Island Court. No injuries were reported in the incident.
7/27	Grand Island Blvd.	Customer Trouble	Employees of McDonald's state that a known subject was on location and threatening to kill an employee over a recent dispute. Deputies' investigation led to the arrest of 20 y/o Jonathan Armitage for Menacing 3 <sup>rd</sup> Degree (Class B Misdemeanor). Armitage was issued an appearance ticket returnable to the Town of Grand Island Court.
7/27	Towerwood Rd.	Suspicious Incident	The complainant states that a vehicle was driving up and down the street and going over peoples lawns. Deputies checked the area but were unable to locate the vehicle by the description given. No damage was reported.
7/28	Baseline Rd.	Larceny	The complainant states that sometime during the night, an unknown person entered her vehicle and stole numerous items.

7/28	East River Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke with the occupants and determined they were having trouble with the phone line.
7/28	Beaver La.	Suspicious Person	The complainant states that a female subject was standing close to the street during the late hours of the night and was concerned she might be struck by a passing vehicle. Deputies checked the area but found no female subject standing near the street.
7/29	East River Rd.	Traffic Complaint	The complainant states that a large truck was parked on the roadway and causing a traffic hazard. Deputies located the truck in question and observed numerous traffic cones were in place to safely guide traffic. The complaint was determined to be unfounded.
7/29	Broadway	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
7/29	Whitehaven Rd.	Suspicious Vehicle	Deputies located a vehicle parked behind a business that was closed during the late evening hours. Deputies spoke with a subject located inside the business and determined it was the owner.
7/29	Bedell Rd.	Suspicious Incident	The complainant states that a strong odor of marijuana is noticed every day and thought it may be coming from an occupied vehicle that is always parked in the lot. Deputies located the vehicle in question and determined the complaint was unfounded after speaking with the occupants.
7/30	Stony Point Rd.	Suspicious Person with Vehicle	Deputies located a suspicious vehicle parked under the South Grand Island Bridges during the late hours of the night. The occupants were advised and left without incident.
7/30	Grand Island Blvd.	Larceny	The complainant states that sometime last week, his bicycle was stolen from the parking lot of Fantasy Island by an unknown person(s).
7/30	Oakridge Dr.	Traffic Complaint	The complainant states that a green colored vehicle was driving recklessly and almost hit the complainant who was walking on the side of the road. The vehicle was last seen driving down Oakridge. Deputies checked the area but were unable to locate the vehicle by the description given.
7/30	Grand Island Blvd.	Suspicious Person	The complainant states that a male subject with no shoes was sitting at a picnic table outside of Adrian's Custard & Beef while drinking a case of beer. Deputies located the subject nearby and advised him.
7/30	Grand Island Blvd.	Larceny	The complainant states that while he was at KOA Campground a person from a neighboring campsite stole various items from his site. Prior to the arrival of Patrol the complaint found the items and stated he no longer required police assistance.
7/30	Williams Rd.	Suspicious Vehicle	The complainant states that a vehicle pulled into the dead end during the late hours of the night. Deputies checked the area but were unable to locate the vehicle by the description given.
7/31	Regency Dr.	Suspicious Incident	The complainant states that an unknown person(s) threw a burning bag of feces on his porch before fleeing the

			area during the late hours of the night. The fire was put out by the homeowner. Deputies checked the area but were unable to locate any subjects involved. No damage was reported.
7/31	Queens Dr.	Suspicious Incident	The complainant states that an unknown person(s) rang his doorbell and fled during the late hours of the night. Deputies checked the area but were unable to locate any subjects.
7/31	Baseline Rd.	Accident PDO	Deputies responded to a report of 2 car motor vehicle accident near the intersection of Webb Rd. No injuries were reported.
7/31	East Park Rd.	Suspicious Incident	The complainant states that sometime during the night, an unknown person(s) egged his vehicle. No damage was reported.
7/31	Stony Point Rd.	Property Found	The complainant states she found a bicycle on her front lawn and wanted to turn it over to Patrol. Deputies transported the bicycle back to the substation.
7/31	Grand Island Blvd.	Disorderly Person	Employees of Fantasy Island state that a patron was causing a disturbance in the park and refusing the leave. Security was able to remove the subject without incident prior to the arrival of Patrol.
