The Erie County Sheriff's Office responded to 171 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

7/27	Love Rd.	Fight	Deputies responded to a report of numerous people fighting in front of Say Cheese Pizza. The subjects involved left prior to the arrival of Deputies. Employees on location stated that only 2 people were involved and did not appear injured before leaving the scene.

7/29	Grand Island Blvd.	Disorderly Conduct	Deputies responded to a report of loud music at an apartment complex. Deputies investigation led to the arrest of 20 y/o Joshua Quezada of Grand Island for Disorderly Conduct (violation), Obstruction of Governmental Administration 2 nd Degree (Class A Misdemeanor), Criminal Nuisance 2 nd Degree (Class B Misdemeanor) and Unlawful Possession of Alcohol by person under the age of 21 (violation). Deputies also arrested 19 y/o Joseph Fago and 20 y/o Jeffrey Trudeau both of North Tonawanda for Unlawful Possession of Alcohol by person under the age of 21. All the subjects were issued appearance tickets returnable to the Town of Grand Island Court.

Collis was turned over to the custody of the City of Tonawanda Police Department.

7/31	Riverdale Dr.	Larceny	The complainant states that sometime during the night, an unknown person(s) stole a purse from her unlocked vehicle.
