The Erie County Sheriff's Office responded to 239 calls the week of this report. Below is a sampling of the noteworthy incidents in **Grand Island**.

| Date | Type           | Street              | Narrative  |

| 8/23 | Runaway        | Huth Rd.            | Deputies received a call involving a 10 year old who stormed out of a residence on Huth Rd. Deputies located the boy at Country Glen Apts. where he was being watched by friend. Appears to have been a misunderstanding, all parties were advised.  |
| 8/24 | Dead Body      | East Park Rd.       | Deputies were contacted by a female reporting that she believes she found her neighbor deceased. Deputies arrived to find the 58 year old female deceased. Deputies completed an investigation and the family was notified.  |
| 8/24 | Larceny        | Country Glen Apts.  | Deputies responded to Country Glen Apts. as a male reported that his trailer and ATV were stolen. Owner works overnight and just got home to find his trailer and ATV gone with the lock having been cut and left on driveway. Police investigation underway, report completed.  |
| 8/24 | Missing Person | Hidden Meadow Trl   | Deputies received a call from a mother stating she cannot locate her 24 year old son. The son left the home a couple days ago and his cell phone is off. Mother said he was having suicidal thoughts the day before. Patrol and detectives are investigating. "Update" 8/28 – A tip from someone on FaceBook led detectives to a mental health facility in Ohio where son checked himself in according to mother who just had contact with him. Case closed. |
| 8/25 | Found Property | Baseline Rd.        | Deputies responded to a report of unknown motorcycle's in a garage at a business. Patrol was able to determine through video surveillance that a delivery van dropped the motorcycles at the wrong location and even forced the locked garage door open to put the bikes in there. The owner of the motorcycles came to get them and paid for the repair to the lock.  |
| 8/26 | Fight          | Holiday Inn Express | Deputies responded to the rooftop lounge at the hotel for a fight called in by several people. Deputies arrived and spoke with all parties. No one was seeking charges and everyone left for the night without further incident.   |
| 8/27 | Dead Body      | Sixth St.           | Deputies responded to family calling stating that their 86 year old father has passed. Deputies investigated the scene and Kaiser Funeral Home came to assist the family further with arrangements.  |

| 8/28 | Disturbance Other | Cinderella Motel | Deputies responded to some type of disturbance at the Cinderella Motel Campground. Parties had a disagreement and one party thought the other was pointing a gun at the other by his arm motion. Deputies confirmed no gun was involved and parties were sent on their way with warnings. |
