

## **Erie County Sheriffs Office Media Release Summary**

The Erie County Sheriff's Office responded to 187 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

8/29	Long Rd.	Suspicious Incident	The complainant states that his vehicle was missing from the parking lot of his place of work. Deputies located the vehicle nearby and determined a co-worker moved the vehicle.
8/29	Whitehaven Rd.	Wires Down	Deputies responded to a report of low hanging wires.  Time Warner cable was notified.
