

Erie County Sheriffs Office Media Release Summary

The Erie County Sheriff's Office responded to 160 calls the week of this report. Below is a sampling of the noteworthy incidents on **<u>Grand Island</u>**.

8/31	Whitehaven Rd	Animal Bite	The complainant states she was bitten by 2 dogs while on Whitehaven Rd. The Dog Control Officer was notified and the complainant was transported to a local hospital with seemingly non-life threatening injuries.
8/31	Bedell Rd.	Attempted Break In	The complainant states that he heard a male subject attempting to break into his residence during the late hours of the night. Deputies located the male subject and determined that he was highly intoxicated and apparently had mistaken the complainant's residence for his own. Charges Pending.
8/31	Love Rd.	Suspicious Incident/Unlawful Possession of Marijuana	The complainant states that a suspicious vehicle was parked at 711 and was occupied by several subjects. The complainant states that the subjects appeared to be smoking marijuana. Deputies located the vehicle nearby and their investigation resulted in the arrest of 18 y/o Amber Carroll of Grand Island for Unlawful Possession of Marijuana (Violation) and several traffic infractions. Carroll was issued an appearance ticket returnable to the Town of Grand Island Court.
8/31	Bedell Rd.	Larceny	The complainant states that sometime in recent days, an unknown person(s) stole various items from her unlocked vehicle.
9/1	Whitehaven Rd.	Larceny	An employee of Noco Express states that an unknown subject entered the store and stole beer. The subject then got into a vehicle and fled. Deputies checked the area but were unable to locate the vehicle. Investigation Ongoing.
9/1	Baseline Rd.	Larceny	The complainant states that sometime during the night, an unknown person(s) stole jewelry from his unlocked vehicle.
9/1	Grand Island Blvd.	Suspicious Incident	The complainant states that while she was in Tops, an unknown person(s) pickpocketed her and stole money. The complainant left the area before speaking to Patrol.
9/1	West River Rd.	Suspicious Incident	The complainant states that a vehicle kept driving by her residence and the occupants inside were yelling at her. Deputies checked the area but were unable to locate the

9/2	Grand Island Blvd.	Loud Music	The complainant states that loud music and yelling was coming from a nearby apartment in her complex. Deputies checked but were unable to locate any loud music.
9/2	Baseline Rd.	Wire Down	Deputies responded to a report of wires down. National Grid was notified.
9/2	East River Rd.	Suspicious Vehicle	The complainant states that a suspicious vehicle was parked underneath the South Grand Island Bridge. Deputies located the vehicle and advised the driver who left without incident.
9/2	Grand Island Blvd.	Reckless Operation	The complainant states that a vehicle was driving recklessly on the road. Deputies located the vehicle parked in a local business unoccupied.
9/3	Grand Island Blvd.	Loud Music	The complainant states that loud music was coming from a nearby apartment in her complex during the late hours of the night. Deputies checked but were unable to locate any loud music.
9/3	White Tail Run	Youth Activity	The complainant states several youths were running around the neighborhood ringing doorbells during the late hours of the night. Deputies located one juvenile subject and returned him to his residence. No damage was observed.
9/3	Staley Rd.	Reckless Operation	The complainant states that a vehicle was speeding down the roadway. Deputies checked the area but were unable to locate the vehicle.
9/3	Jen Ct.	Suspicious Incident	The complainant states that a male subject knocked on his door and told him there was a person walking around the neighborhood with a gun. The male subject then got into a vehicle and left. Deputies checked the area thoroughly and did not locate any subject with a gun or the male subject who reported it. Deputies determined the complaint to be unfounded.
9/3	Love Rd.	Larceny	An employee at 711 states that a known subject stole beer from the store. Investigation Ongoing.
9/3	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
9/3	Beaver Island State Pkwy	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
9/4	Love Rd.	Suspicious Incident	The complainant states that she observed several youths that appeared to be breaking into her vehicle during the late hours of the night. The complainant yelled at the subjects and they fled in an unknown direction. Deputies checked the area but were unable to locate any subjects. No damage was observed and nothing was reported missing.

9/4	Long Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
9/4	Stony Point Rd.	Reckless Operation	The complainant states that a vehicle was swerving into oncoming traffic. The complainant was able to follow the vehicle to the residence of the registered owner.

9/5	Marlin Dr.	Suspicious Vehicle	The complainant states that a suspicious vehicle was parked near her residence during the late hours of the night. Deputies checked and determined the complaint to be unfounded.
9/5	East River Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
9/5	Long Rd.	Suspicious Incident	The complainant states that while she was driving on the I-190 she observed a male subject on the property of the abandoned Dunlop Building. The complaint had no further information and continued driving to her destination. Deputies checked the area but were unable to locate any subjects. No damage was observed.
9/5	East River Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
9/5	Bedell Rd.	Youth Activity	The complainant states that several youths were throwing rocks at passing vehicles. Deputies located the youths and advised them. No damage was reported.
9/5	Oakridge Dr.	Youth Activity	The complainant states a group of youths were running through yards in the area. Deputies located several youths in the area and advised them.
9/5	Staley Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
9/6	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
9/6	South La.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke to the occupants of the residence and determined the call to be a misdial.
9/6	Grand Island Blvd.	Suspicious Person	The complainant states that a female subject was kicked off of the bus and was talking to herself about fleeing the country. Deputies checked the area but were unable to locate any person matching the description given.
9/6	Whitehaven Rd.	Suspicious Vehicle	Employees of the Byblos Niagara Spa & Resort state that a vehicle was running in the parking lot with no one around for several hours. Deputies found the vehicle but were unable to make contact with the owner.
