The Erie County Sheriff's Office responded to 160 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

| Date | Street | Type | Narrative |

| 9/7 | Baseline Rd. | Pistol Permit Investigation | Deputies conducted a background check of an individual who applied for a pistol permit. |
| 9/7 | Bedell Rd. | Suspicious Incident | The complainant states that sometime in recent days, an unknown person(s) forced open a gate at the Miracle League Field. No damage was observed. |
| 9/7 | Love Rd. | Warrant Serve | Deputies arrested 18 y/o Robert Rovison on an outstanding Bench Warrant issued from the Town of Amherst. Rovison was transferred to the custody of the Amherst Police Department. |
| 9/8 | Independence La. | Suspicious Person with Vehicle | The complainant states that several youths were standing near a parked vehicle. Deputies located the subjects, one of which owned the vehicle, and advised them. |
| 9/8 | West Park Rd. | Loud Music | The complainant states that loud music was coming from a nearby residence during the late hours of the night. Deputies advised the occupant of the residence. |
| 9/8 | Suspicious Person with Vehicle/Unlawful Possession of Marijuana | Sawmill Run | While in the area investigating a similar complaint, Deputies located a vehicle parked in the street that was occupied by 3 subjects during the late hours of the night. Further investigation revealed the subjects had been smoking marijuana inside the vehicle. Deputies arrested 22 y/o Adam Alkhatib, 18 y/o Jacqueline Johnston, and 18 y/o Ayla Marino all of Grand Island for Criminal Possession of Marijuana 5 th Degree (Class B Misdemeanor). All subjects were issued appearance tickets returnable to the Town of Grand Island Court. |
| 9/8 | West River Rd. | Hit & Run Accident | The complainant states that a vehicle struck several mailboxes and then fled in an unknown direction. Deputies checked the area but were unable to locate any vehicles that may have been involved. |
| 9/8 | East River Rd. | Suspicious Incident | The complainant states that a male subject was throwing out personal items in a dumpster belonging to a local business. The complainant spoke to the owner of the business and then informed Patrol that the subject had permission to throw the items out in the dumpster. |

| 9/8 | Grand Island Blvd. | Accident PDO | Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported. |
| 9/8 | Whitehaven Rd. | Reckless Operation | The complainant states that a gold colored vehicle was running cars off the roadway but could provide no further information about the vehicle. Deputies checked the area but were unable to locate any vehicle matching the description given. |
| 9/8 | Baseline Rd. | Motorist Broke Down | Deputies assisted a motorist whose vehicle had become disabled. |
| 9/8 | Baseline Rd. | Accident Injury | Deputies responded to a report of a 2 car motor vehicle accident in a head on collision. 1 driver was transported to a local hospital with seemingly non-life threatening injuries. The driver of the 2 nd vehicle was treated on scene by the Grand Island Fire Department but refused transport to the hospital. |
| 9/9 | Carol La. | Reckless Operation | The complainant states that a vehicle was travelling at a high rate of speed down the street. Deputies checked the area but were unable to locate the vehicle. |
| 9/9 | Whitehaven Rd. | ATV Operation | The complainant states that an ATV was operating in the street on Whitehaven Rd. Deputies checked the area but were unable to locate the vehicle. |
| 9/10 | East River Rd. | Residential Fire | Deputies assisted the Grand Island Fire Department for a report of a house fire. |
| 9/10 | Stony Point Rd. | Welfare Check | Deputies responded to a report of a 911 hang up call. Deputies spoke to the occupants of the residence and determined the call to be a misdial. |
| 9/10 | East River Rd. | Suspicious Person with Vehicle | The complainant states that a vehicle was parked underneath the South Grand Island Bridge during the late hours of the night and the occupants appeared to have backpacks on. Several other subjects on foot also appeared to be with the vehicle in question. The vehicle left prior to the arrival of Patrol but the complainant was able to obtain a license plate number. Deputies spoke to the driver of the vehicle and advised him. |
| 9/11 | Enola Rd. | Barking Dog | The complainant states a dog at a nearby residence was barking for several hours late at night. Deputies spoke to the owner of the dog who brought the dog inside the residence for the night. |
| 9/11 | Grand Island Blvd. | Larceny | The complainant states that a known person(s) withdrew a sum of money from an ATM while they were at Fantasy Island. Investigation Ongoing. |
| 9/11 | Baseline Rd. | Welfare Check | Deputies responded to a report of a 911 hang up call. Deputies spoke to the occupants of the residence and determined the call to be a misdial. |
| 9/12 | Fix Rd. | Larceny | The complainant states that during recent days an unknown person(s) stole mail from her mailbox. |
| 9/12 | Grand Island Blvd. | Motorist Broke Down | Deputies assisted a motorist whose vehicle had become disabled. |
| 9/12 | Riverwoods Dr. | Refer to Patrol | The complainant states that an unknown person(s) dumped paint in the roadway. The Grand Island Highway Department was notified. |
| 9/12 | South State Pkwy. | Reckless Operation | The complainant states that a vehicle was traveling northbound in the southbound lane while on South State |

| 9/13 | Bush Rd. | Suspicious Incident | The complainant states that sometime in the early hours of the morning, an unknown person(s) opened the door to his vehicle. Nothing was reported stolen and no damage was observed. |
| 9/13 | Huth Rd. | Accident PDO | Deputies responded to a report of a 3 car motor vehicle accident. No injuries were reported. |
| 9/13 | Legion Dr. | Parking Violation | The complainant states that vehicles were parked on the roadway and were obstructing traffic. Deputies checked and determined the complaint to be unfounded. |
