The Erie County Sheriff's Office responded to 183 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

9/8	Ward Park Rd.	Loud Music	Complainant states that loud music was coming from a residence in the neighborhood. Deputies located the source of the music and advised the homeowner.

McCaslin was issued an appearance ticket returnable to the Town of Grand Island Court and released to a sober 3 rd party.

9/9	Waterford Pk.	Suspicious Incident	Complainant states that a suspicious male subject was entering neighbors cars in the area late at night. The complainant confronted the subject and the subject fled the area. Deputies checked the area but were unable to locate the subject. The subject was described as a White male, medium build, short spikey dark hair. Nothing was reported missing from the vehicles the complainant witnessed the subject enter. Investigation Ongoing.
