The Erie County Sheriff's Office responded to 174 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

| 9/12 | Love Rd. | Animal Complaint | The complainant states that an injured Canadian Goose was walking around near the roadway. Deputies checked but were unable to locate the injured animal. |
| 9/12 | Industrial Dr. | Suspicious Vehicle | Deputies located a vehicle parked near a business after closing hours. The occupants were located nearby and advised. |
| 9/12 | East River Rd. | Suspicious Vehicle | The complainant states that a white van with tinted windows was parked underneath the South Grand Island Bridge. Deputies checked but were unable to locate the vehicle by the description given. |
| 9/13 | Orchard Pl. | Animal Loose | The complainant states a dog was running loose in the neighborhood. The Dog Control Officer was notified. |
| 9/13 | Brandywine Dr. | Criminal Mischief | The complainant states that sometime during the night, an unknown person(s) damaged her mailbox. |

| 9/15 | Whitehaven Rd. | Customer Trouble | A tour guide states that he was having a problem getting payment from a group he provided a service to. The issue was resolved amongst all parties. |

| 9/15 | Bedell Rd. | Suspicious Person | The complainant states that a male subject was going door to door in her apartment complex asking for cigarettes. Deputies located the male subject nearby and advised him. |
| 9/15 | East Park Rd. | Suspicious Incident | The complainant states that several youths were seen entering a nearby vacant house in the past few days. Deputies checked but observed no damage and found no persons on the property. |
| 9/15 | Fairview Ct. | Animal Complaint | The complainant states that a neighbor's dog got loose and attacked his dog. The Dog Control Officer was notified. |
| 9/15 | Love Rd. | Traffic Complaint | The complainant states that a 14 y/o male subject was driving a vehicle that was currently parked in the lot of 7-11. Deputies located the vehicle and determined the male was only a passenger and the driver had a valid license. |
| 9/16 | East River Rd. | Disorderly Person | The complainant states that contractors in the area completing a job were using a nearby vacant lot as a bathroom. Deputies advised the contractors. |
| 9/16 | Bedell Rd. | Criminal Mischief | The complainant states that 3 youths were seen running from the bathrooms in Veterans Park and when the complainant checked he observed extensive damage to the building. Deputies checked the area but were unable to locate the youths. Investigation Ongoing. |
| 9/17 | West River Rd. | Attempted Burglary | The complainant states that sometime in recent days an unknown person(s) attempted to gain entry into her residence by cutting several screen windows. No entry was made and nothing was reported stolen. |
| 9/17 | Sandy Beach Rd. | Suspicious Person with Vehicle | The complainant states that during the previous day a male subject with a light blue pickup truck appeared to be in the area picking up scrap and while there made a pass at her. The complainant was advised to contact Patrol immediately if she observed the vehicle again. |
| 9/17 | Grand Island Blvd. | Accident PDO | Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported. |
| 9/17 | Colonial Dr. West | Suspicious Vehicle | The complainant states that a vehicle was outside of a neighbor's residence that did not belong and a light was on inside the house. Deputies spoke with the homeowner and determined nothing to be out of order. |
