



## Erie County Sheriffs Office Media Release Summary

The Erie County Sheriff's Office responded to 218 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
8/22	Ferry Rd.	Fight	Patrol responded to a report of a fight at Sand-Dees Pub involving numerous parties during the late hours of the night. Deputies arrived and located 2 victims that suffered minor injuries from the fight. The victims were treated on scene by the Grand Island Fire Department. No parties wished to pursue any charges.
8/22	Sturbridge La.	Unknown Trouble	The complainant states that she heard a female yelling in the street somewhere in the area during the late hours of the night. Deputies checked the area but were unable to locate any subjects.
8/22	Riverview Ct.	Youth Activity	The complainant states that there was a large group of youths congregating in front of her house during the late hours of the night. Deputies checked the area but found no youths.
8/22	Grand Island Blvd.	Burglary In Progress	An employee of Express Cleaners states that a male subject just came into the store through the rear entrance and stated to give him all the money. The male reportedly stole an unknown amount of cash and then fled the store in an unknown direction. Erie County Sheriff's Office Detectives investigation revealed the complainant fabricated the story. The employee, 26 y/o Teresa Wright of Grand Island, was arrested for Falsely Reporting an Incident (Class A Misdemeanor) and released on an appearance ticket returnable to the Town of Grand Island Court.

Traffic Arrest	Following a traffic stop, Deputies arrested 52 y/o Gregory Vinal of Amherst for Operating a Motor Vehicle with a Suspended Registration (Misdemeanor) and other traffic infractions after a DMV check showed the registration to the car was suspended. Vinal was issued an appearance ticket returnable to the Town of Grand Island Court.

Traffic Arrest	Following a traffic stop, Deputies arrested 26 y/o Perry Hill of Buffalo for Aggravated Unlicensed Operation 3 <sup>rd</sup> Degree (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently revoked. Hill was issued an appearance ticket returnable to the Town of Grand Island Court.
8/22	Grand Island Blvd.	Disorderly Person	Employees of Fantasy Island state that a male subject was causing a disturbance in the park and refusing to leave. The subject left without incident prior to the arrival of Patrol.
8/22	Grand Island Blvd.	Traffic Arrest	Following a traffic stop, Deputies arrested 44 y/o Christopher Gordon of Niagara Falls for Aggravated Unlicensed Operation 3 <sup>rd</sup> Degree (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently suspended. Gordon was issued an appearance ticket returnable to the Town of Grand Island Court.
8/22	Bedell Rd.	Noise Complaint	The complainant states that loud music was coming from a nearby residence. Deputies located the source of the music and advised the homeowners.
8/22	Whitehaven Rd.	Fireworks Use	The complainant states that someone was using fireworks in the area during the late hours of the night. Deputies located the source of the fireworks and advised the subjects.
8/23	Stony Point Rd.	Suspicious Incident	The complainant states that several cars were pulling up in the street and several kids were getting out the vehicles during the late hours of the night. Deputies checked the area but found nothing suspicious.
8/23	Center Court North	Suspicious Vehicle	The complainant states that a vehicle with out of state plates was parked in the lot for several weeks. Deputies spoke with employees of the apartment complex and learned the owner had permission to park in the lot.
8/23	East River Rd.	Customer Trouble	Employees of River Oaks Marina state that a customer was causing a disturbance after a dispute over a bill. Prior to the arrival of Patrol the subject left and employees stated they no longer needed police assistance.
8/23	East River Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident near the intersection of Winter Rd. No injuries were reported.

Traffic Arrest	Following a traffic stop, Deputies arrested 18 y/o Joshua Falsone of Kenmore for Aggravated Unlicensed Operation 2 <sup>nd</sup> Degree (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently suspended. Falsone was issued an appearance ticket returnable to the Town of Grand Island Court.
8/24	Winter Rd.	Larceny	The complainant states that while she was at the Sandy Beach Yacht Club for a party, an unknown person(s) stole her wallet.
8/24	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of Burger King. No injuries were reported.
8/24	Woodstream Dr.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle

			accident near the intersection of White Tail Run. No injuries were reported.
8/24	Grand Island Blvd.	Larceny	Employees of Tai Pei Chinese Restaurant state that a male subject came into the store and stole money from the tip jar while employees weren't looking. The male subject got into a red PT Cruiser and fled the area. Employees stated that it was the 2 <sup>nd</sup> time in a week that the same subject had taken money. While investigating, Deputies located a witness that saw the license plate of the suspect vehicle. Investigation Ongoing.
8/24	Grand Island Blvd.	Traffic Arrest	Following a traffic stop, Deputies arrested 47 y/o Kevin Curry of Clarence for Aggravated Unlicensed Operation 3 <sup>rd</sup> Degree (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently suspended. Curry was issued an appearance ticket returnable to the Town of Grand Island Court.
8/24	Grand Island Blvd.	Property Found	The complainant states that he found a wallet and wished to turn it over to Patrol. Deputies were able to contact the owner with information found inside the wallet and returned the property.
8/24	Ransom Rd.	Traffic Complaint	The complainant states that a male subject on a green motorcycle was driving over 100mph on Ransom Rd. Deputies checked the area but were unable to locate the subject or vehicle.
8/24	Flannigan St.	Warrant Arrest	Following a traffic stop, Deputies arrested 28 y/o Danisha McKenzie of Kenmore after a check showed she had an outstanding Arrest Warrant from the Town of Cheektowaga. McKenzie was transferred to the custody of the Cheektowaga Police Department.
8/24	East River Rd.	Suspicious Incident	The complainant states that a female subject came to her residence and stated she was from the US Census Bureau. The female gave the complainant a pamphlet and asked a few questions before leaving the area. Deputies checked but were unable to locate the female by the description given.
8/25	Grand Island Blvd.	Larceny	The complainant states that sometime during the past few days an unknown person(s) stole various construction items from a job site.
8/25	East Park Rd.	Traffic Complaint	The complainant states that a pickup truck with a trailer was driving fast through the neighborhood. Deputies checked the area but were unable to locate the vehicle by the description given.
8/25	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of M&T Bank. No injuries were reported.

Suspicious Incident	The complainant states that he observed several youths in the area of River Oaks Marina who appeared to have stolen alcohol from boats docked nearby during the late hours of the night. The youths got into a vehicle and left the area. Deputies located the vehicle nearby but determined nothing was stolen.
8/26	Red Jacket Rd.	Suspicious Incident	The complainant states that 3 youths were walking down the road looking into vehicles during the late hours of the

			night. Deputies located the youths nearby and advised them. Nothing was reported stolen or damaged.
8/26	Love Rd.	Larceny	The complainant states that sometime during the night, an unknown person(s) stole various items from his vehicle after smashing out a window.
8/26	Love Rd.	Larceny	The complainant states that sometime during the night, an unknown person(s) smashed her car window and stole a purse from inside.
8/26	First St.	Traffic Complaint	The complainant states that 2 vehicles were drag racing down the street. Deputies checked the area but were unable to locate the vehicles by the description given.
8/26	Ransom Rd.	ATV Operation	The complainant states that an ATV was being operated on the football field of the Grand Island High School. Deputies located the ATV and driver nearby and advised him. No damage was reported.
8/26	Whitehaven Rd.	Traffic Complaint	The complainant states that a gold colored Mercury Sable was swerving all over the road. Deputies checked the area but were unable to locate the vehicle by the description given.
8/26	Love Rd.	Larceny	The complainant states that sometime during the night, an unknown person(s) stole various items from his unlocked vehicle.
8/27	East River Rd.	Suspicious Vehicle	Deputies located a suspicious vehicle parked at Fisherman's Landing during the evening hours. The occupant was advised.
8/27	Revere Rd.	Welfare Check	Patrol responded to a report of a 911 hang up call at a residence. Deputies spoke with the occupants and determined the call was a misdial.
8/28	East River Rd.	Suspicious Incident	The complainant states that someone tried to break into his residence during the night by cutting a screen window. No entry was made and nothing was reported stolen.
8/28	Warner Dr.	Burglary	The complainant states that sometime during the night, an unknown person(s) entered her garage and stole 2 gas cans from inside. The gas cans were found on the lawn of a nearby residence and returned to the owner.
8/28	Grand Island Blvd.	Warrant Arrest	Deputies received a tip that a subject wanted on a Parole Warrant was eating in Brick Oven Pizza. Deputies located the subject, 20 y/o Vincent Collis, inside and asked him to step outside the restaurant. Collis immediately tried to run and a short foot pursuit ensued. Collis was caught nearby and charged with Obstruction of Governmental Administration 2 <sup>nd</sup> Degree (Class A Misdemeanor) and Resisting Arrest (Class A Misdemeanor). Collis was transported to the Erie County Holding Center pending his arraignment in the Town of Grand Island Court.
8/28	Harvey Rd.	Noise Complaint	The complainant states that loud music was coming from a nearby residence during the late hours of the night. Deputies located the source of the music and advised the occupants.
