



Erie County Sheriffs Office Media Release Summary

Dates: 8/25/2012 to 8/31/2012

The Erie County Sheriff's Office responded to 176 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
8/25	Woodstream Dr.	Fireworks Use	Complainant states that fireworks were being used in the area. Deputies located the source of the fireworks and advised the subjects.
8/25	Greenway Rd.	Suspicious Incident	Complainant states that his neighbors car door was open and appeared to have been rummaged through sometime during the night. Deputies located the owner of the vehicle, who confirmed it was not in the same condition as when she last saw it. The owner inventoried the items inside and reported that nothing appeared missing.
8/25	East River Rd.	Attempted Break In	Complainant states that sometime in recent days, an unknown person(s) attempted to break into a shed on her property. At the time of the report nothing was reported missing. Investigation Ongoing.
8/25	East Park Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
8/25	East River Rd.	Road Obstruction	Complainant states that an unknown person(s) placed traffic cones in the roadway. Deputies removed the cones.
8/26	Ward Park Rd.	Suspicious Vehicle	Complainant states that a suspicious vehicle was parked on the street late at night, and appeared to be occupied. Deputies located the vehicle and advised the subjects.
8/26	West River Rd.	Animal Loose	Complainant states a loose dog was running through the neighborhood. The Dog Control Officer was notified.
8/26	Whitehaven Rd.	Reckless Operation	Complainant states that a vehicle was weaving in and out of traffic on Whitehaven Rd. Deputies checked the area but were unable to locate the vehicle.
8/26	Baseline Rd.	Criminal Mischief	Complainant states that doors to a business had been damaged sometime during the night.
8/26	Grand Island Blvd.	Disorderly Person	Deputies assisted security at Fantasy Island in removing a disorderly female. The female left without incident.
8/26	East River Rd.	Suspicious Incident	Complainant states sometime in recent days, an unknown person(s) put small fish in his mailbox.
8/27	Grand Island Blvd.	Parking Complaint	Complainant states that several semi-trucks were parked in the Grand Island Plaza late at night with their engines running. Deputies advised the truck drivers.
8/27	Grand Island Blvd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.

8/27	Hemlock Dr.	Fireworks Use	Complainant states that fireworks were being used in the area. Deputies located the source of the fireworks and advised the subjects.
8/28	Fix Rd.	Road Obstruction	Complainant states that an unknown person(s) placed numerous garbage cans in the roadway. Deputies removed the garbage cans.
8/28	West River Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
8/28	Whitehaven Rd.	Drunk Driving	Deputies responded to multiple reports of a vehicle driving erratically on Whitehaven Rd. Their investigation led to the arrest of 46 y/o David Wylke of Tonawanda for Driving While Intoxicated. Wylke refused to submit a sample of his breathe for chemical analysis. Wylke was issued an appearance ticket returnable to Town of Grand Island Court and was released to a sober 3 rd party.
8/29	Grand Island Blvd.	Warrant Arrest	Following a traffic stop, Deputies arrested 25 y/o Jacklyn Mysliwicz of Grand Island after a check showed she had an outstanding Bench Warrant from the Town of Amherst. Mysliwicz was turned over to the custody of the Amherst Police Department.
8/29	Woodlee La.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
8/29	Whitehaven Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
8/29	East River Rd.	Shots Fired	Complainant states he heard several shots fired in the area of East River Rd. and Fix Rd. Deputies checked the area but were unable to locate the source of the suspected shots. The complainant further stated he was unsure if the noise could have come from fireworks.
8/30	Stony Point Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke to the homeowner and determined the call was a misdial.
8/30	Whitetail Run	Residential Burglary	Complainant states that sometime in recent days, an unknown person(s) broke into her residence and stole various items. Investigation Ongoing.
8/31	East River Rd.	Deer Struck	Complainant states a deer had been struck by a vehicle and appeared to be deceased on the side of the road. The deer was removed from the roadway and NITTEC was notified.
8/31	East Park Rd.	Parking Complaint	Complainant states that a parked vehicle was blocking the sidewalk. Deputies located the owner, who moved the vehicle and was advised of the parking laws.
8/31	Ransom Rd.	Suspicious Vehicle	Complainant states that 2 suspicious vehicles were parked near the Grand Island High School Football Field late at night. Deputies located the vehicles and the owners who were restocking the concession stand.
