The Erie County Sheriff's Office responded to 212 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
9/1	Grand Island Blvd.	Drunk Driving	Deputies responded to a report of a female attempting to sell drugs in the TC's Lounge parking lot. Their investigation led to the arrest of 43 y/o Margaret Vucetic of Grand Island, for Driving While Intoxicated. Vucetic refused to submit a sample of her breathe for chemical analysis. Vucetic was issued an appearance ticket returnable to Town of Grand Island Court and she was released to a sober 3 <sup>rd</sup> party.
9/1	Bush Rd.	Drunk Driving	Deputies responded to a report of a motor vehicle that crashed into a residence on Bush Rd. Deputies investigation led to the arrest of 29 y/o Gregory Golde of Grand Island, for Driving While Intoxicated and other traffic infractions. Golde refused to submit a sample of his breathe for chemical analysis and was transported to a local area hospital with seemingly non-life threatening injuries. Golde was issued an appearance ticket returnable to Town of Grand Island Court.
9/1	Baseline Rd.	Wires Down	Deputies responded to a report of low hanging wires that were obstructing traffic. National Grid was notified.
9/1	Grand Island Blvd.	Reckless Operation	Complainant states that a vehicle cut her off and was speeding down the roadway. Deputies checked the area but were unable to locate the vehicle.
9/1	Grand Island Blvd.	Larceny	Complainant states that while he was inside the water park at Fantasy Island, an unknown person(s) stole his cell phone.
9/1	Whitehaven Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
9/1	Baseline Rd.	Accident Hit & Run	Complainant states that a dark colored vehicle rear ended him, and then sped off. Deputies checked the area but were unable to locate the vehicle. No injuries were reported.
9/2	Love Rd.	Criminal Mischief	Complainant states that a vehicle drove down the road and was smashing mailboxes. Deputies checked the area

			but were unable to locate the vehicle.
9/2	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
9/2	Grand Island Blvd.	Suspicious Person	Employees at Just Pizza state that 2 males were sitting outside of the restaurant and occupying tables meant for customers. Deputies located the subjects and advised them.
9/2	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
9/2	Staley Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
9/2	Grand Island Blvd.	Larceny	Complainant states that while she was working in the Fantasy Island Water Park, an unknown person(s) stole her cell phone.
9/2	Pin Oak Cr.	Fireworks Use	Complainant states that fireworks were being used in the area. Deputies checked but were unable to locate the source of the fireworks.
9/2	Waterford Park	Loud Music	Complainant states that loud music was coming from a party in the neighborhood. Deputies located the source of the music and advised the homeowner to turn it down.
9/2	Broadway	Shots Fired	Complainant states that he heard subjects in the yards on Broadway, and then he heard 3 shots fired in the area. Deputies checked the area but were unable to locate any subjects.
9/2	Huth Rd.	Youth Activity	Complainant states that several youths were running through the neighborhood and throwing things at vehicles. Deputies located several subjects in the area but were unable to determine if they were involved.
9/2	East River Rd.	Reckless Operation	Complainant states that a pickup truck was swerving all over the road. Deputies checked the area but were unable to locate the vehicle.
9/3	Calvano Dr.	Property Found	Complainant states that he found a wallet and wanted to turn it over to Patrol. Deputies were able to contact the owner and return the property.
9/3	Grand Island Blvd.	Disorderly Person	Employees at Fantasy Island state that a subject was becoming disorderly in the park. The subject left without incident prior to Patrols arrival.
9/3	North Colony Rd.	Larceny	Complainant states that sometime in recent days, an unknown person(s) stole his mailbox.
9/3	Staley Rd.	Animal Complaint	Complainant states that a large bird seemed to be injured on the side of the roadway. Deputies checked the area but were unable to locate the animal.
9/4	Harvey Rd.	Suspicious Person	Complainant states that a suspicious male was walking through people's front yards during the early hours of the morning. Deputies checked the area but were unable to locate the subject.
9/4	Ransom Rd.	Assault	Complainant states that while she was at Grand Island High School, a known person assaulted her. Deputies investigation led to the arrest of a Juvenile Offender from Grand Island for Assault 3 <sup>rd</sup> Degree (Class A Misdemeanor). The Juvenile Offender was issued an appearance ticket returnable to Town of Grand Island Court and released to the custody of her mother.

9/4	East River Rd.	Animal Injury	Complainant states that a large turtle appeared to have been hit by a car. Deputies removed the turtle from the roadway.
9/5	Whitehaven Rd.	Deer Struck	Complainant states that an injured deer was in the roadway. Deputies checked the area but were unable to locate the deer.
9/5	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
9/5	Stony Point Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
9/5	Stony Point Rd.	Suspicious Incident	Complainant states a suspicious bag was on a park bench with no one around it. Deputies located the bag which contained a bowling ball.
9/5	Love Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
9/5	Fix Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
9/5	Bedell Rd.	Larceny	Complainant states that sometime during the night, and unknown person(s) stole a brass sprinkler from his lawn.
9/6	Alt Blvd.	Larceny	Complainant states that an unknown person(s) stole a laptop that had been delivered earlier in the day. Investigation Ongoing.
9/6	Baseline Rd.	Animal Loose	Complainant states that he found a loose dog running through the neighborhood. The Dog Control Officer was notified.
9/6	Baseline Rd.	Marijuana Possession	Following a traffic stop and subsequent investigation, Deputies arrested 22 y/o Stephen Niver of Grand Island for Unlawful Possession of Marijuana (A Violation) and traffic infractions. Niver was issued an appearance ticket returnable to Town of Grand Island Court.
9/6	Ferry Rd.	Suspicious Person	Complainant states that a suspicious male was walking on Ferry Rd. during the late evening hours. Deputies located the subject who was walking home from a local business.
9/7	East River Rd.	Suspicious Person	Complainant states that 2 male subjects were walking around River Oaks Marina and looked suspicious. Deputies checked the area but were unable to locate the subjects.
9/7	Carl Rd.	Suspicious Person	Deputies located several subjects at the playground on Carl Rd. late at night. The subjects were advised and left the premise. No damage was observed.
9/7	Grand Island Blvd.	Refer to Patrol	Complainant states that construction workers were using heavy machinery at First Niagara Bank late at night. Deputies advised the workers who ceased using the loud machinery.
