



Erie County Sheriffs Office Media Release Summary

Dates: 8/18/2012 to 8/24/2012

The Erie County Sheriff's Office responded to 195 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

8/18	East River Rd.	Larceny	Complainant states that a known person was stealing checks from his residence. Deputies investigation led to the arrest of a Juvenile Offender for Grand Larceny 4 th Degree (Class E Felony), Petit Larceny (Class A Misdemeanor), Forgery 3 rd Degree (Class A Misdemeanor), and Possession of a Hypodermic Instrument (Class A Misdemeanor). The 20 y/o Juvenile Offender was transported to the Erie County Holding Center pending arraignment in the Town of Grand Island Court.
8/18	Pin Oak Cr.	Suspicious Vehicle	Complainant states that a suspicious vehicle was abandoned on the street. Prior to Deputies arrival, the vehicles driver returned and left the area.
8/18	Beaver La.	Narcotics	Deputies investigation into a larceny complaint in the area led to the arrest of a 20 y/o Juvenile Offender for Possession of a Hypodermic Instrument (Class A Misdemeanor). The Juvenile Offender was issued an appearance ticket returnable to Town of Grand Island Court.
8/18	Tracey La.	ATV Operation	Complainant states that subjects were operating dirt bikes on the street and through private property. Deputies checked the area but were unable to locate the subjects.
8/18	East River Rd.	Suspicious Person	Complainant states that an intoxicated male was seen getting into a vehicle and possibly going to drive away. Deputies located the male who was only retrieving property from the vehicle.
8/18	Grand Island Blvd.	Fight	Employees at Fantasy Island state that several subjects were fighting inside the amusement park. Deputies located the subjects involved and escorted them from the premise without incident. No injuries were reported.
8/18	East River Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
8/18	Grand Island Blvd.	Youth Activity	Complainant states that several youths were wandering around in the roadway. Deputies located the youths, who were waiting for the bus, and advised them to stay out of the street.

8/18	Baseline Rd.	Suspicious Person	Complainant states that 2 subjects were jumping in and out of traffic. Deputies located the subjects and advised them.
8/18	1 st St.	Loud Music	Complainant states that loud music was coming from a residence late at night. Deputies located the source of the music and advised the homeowner.
8/18	River Oaks Dr.	Loud Music	Complainant states that loud music was coming from a residence late at night. Deputies located the source of the music and advised the homeowner.
8/19	Greenway Rd.	Suspicious Incident	Complainant states that a neighbor was shooting a BB gun in his yard and damaged the complainants residence. Deputies spoke to all parties involved and advised them.
8/19	East River Rd.	Attempted Break In	<p>Deputies responded to a report of an alarm ringing on East River Rd. While en route, Deputies received a call from the homeowner who stated a male subject was attempting to break into the residence through a window. The male subject began to flee when the alarm sounded. Deputies checked the area but were unable to locate the subject. Erie County Sheriffs Detectives and Crime Scene Unit responded to the scene. An investigation into the matter is Ongoing.</p> <p>The suspect is described as a White male in his early 20's with dark colored hair. 8/19	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
8/19	Grand Island Blvd.	Animal Complaint	Complainant states that a dog was inside of a parked vehicle and appeared to be in distress. Deputies were able to locate the owner and determined the dog was in good health.
8/19	I-190	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
8/19	East River Rd.	Trespass	Complainant states that 3 youths were trespassing on his dock. Deputies located the youths and advised them.
8/20	Love Rd.	Fire Investigation	Erie County Sheriffs Detectives from the Arson Investigation Unit assisted Grand Island Fire Department with their investigation into a barn fire on Love Rd. The cause of the fire is yet to be determined.
8/20	Fix Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
8/20	Marilyn Dr.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke to the homeowner and determined the call was a misdial.
8/20	Long Rd.	Youth Activity	Complainant states that youths were hanging out around the Dunlop Tire Corp. Building. Deputies located the youths and escorted them from the property without incident. No new damage was observed.
8/20	Jamestown Rd.	Criminal Mischief	Complainant states that sometime during the night an unknown person(s) damaged property in her front yard.
8/20	Huth Rd.	Suspicious Person	Deputies located 2 subjects long boarding late at night. The subjects were advised.

8/21	Forest Creek La.	Loud Music	Complainant states that loud music was coming from a residence late at night. Deputies located the source of the music and advised the homeowner.
8/21	Grand Island Blvd.	Suspicious Vehicle	Deputies located a suspicious vehicle parked on the side of the road late at night. The driver appeared to be lost and Deputies assisted him in locating his destination.
8/21	Grand Island Blvd.	Larceny	Complainant states that sometime during the night, an unknown person(s) stole scrap metal from his property. Investigation Ongoing.
8/21	East River Rd.	Suspicious Person	Complainant states that a suspicious male was walking underneath the South Grand Island Bridge with various items in his hands. Deputies located the subject who stated he was walking to the bus stop.
8/21	Ransom Rd.	Larceny	Complainant states that a known subject stole her bicycle from Grand Island High School. Deputies located the subject who agreed to return the bicycle. The complainant did not wish to pursue charges.
8/21	Ransom Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke to the homeowner and determined the call was a misdial.
8/21	Huth Rd.	Missing Person	Complainant states that his 6 y/o grandchild went missing from a playground. Deputies and family members were able to locate the child a short distance away. The child had wandered away and was unharmed.
8/21	Kirkwood Dr.	Suspicious Person	Complainant states that 2 subjects in a canoe, were firing a pellet gun. Deputies checked the area but were unable to locate the subjects who apparently entered back into the Niagara River.
8/21	Grand Island Blvd.	Accident Hit & Run	Complainant states that a vehicle struck a parked vehicle and caused substantial damage. The suspect vehicle then fled the scene. Deputies checked the area but were unable to locate the vehicle. No injuries were reported.
8/21	Whitehaven Rd.	Accident Injury	Deputies responded to a report of a 2 car motor vehicle accident. 2 occupants were transported to local hospitals with seemingly non life threatening injuries.
8/21	Ferry Rd.	Criminal Mischief	Complainant states that sometime in recent days, an unknown person(s) egged his residence causing minor damage.
8/21	Bedell Rd.	Suspicious Incident	Complainant states that he heard a female screaming on the bike path in the area of the Country Glen apartments. Deputies checked the area but were unable to locate any subjects.
8/21	Schwegler Rd.	Suspicious Incident	Complainant states that several subjects were knocking on doors in the neighborhood and using fireworks. Deputies checked the area and found several subjects walking, but all denied any knowledge of the incident.
8/22	Grand Island Blvd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle ran out of fuel.
8/22	Ferry Rd.	Suspicious Vehicle	Complainant states that a vehicle had been parked in the Anchor Marine parking lot for approximately a week. Deputies were able to locate the registered owner, who owned a boat docked at the marina.
8/22	Whitehaven Rd.	Burglary	Deputies responded to a report of a burglary alarm at the

			WUTV Fox 29 building. Upon arrival, Deputies found a door that had seemingly been pried open. As Deputies were searching the building, they found 2 subjects inside who fled when they saw Patrol. As the subjects fled out of a door, they were detained by another Deputy who was posted on the perimeter. Deputies charged 21 y/o Matthew Ludwig and 21 y/o Nicholas Muoyo, both of Grand Island, with Burglary 3 rd Degree (Class D Felony), Criminal Mischief 3 rd Degree (Class E Felony) and Possession of Burglar Tools (Class A Misdemeanor). Both subjects were transported to the Town of Grand Island Court for arraignment.
8/23	Bedell Rd.	Suspicious Person	Complainant states that 3 suspicious males walked out of the woods and through the parking lot of Country Glen Apartments. Deputies checked the area but were unable to locate the subjects.
8/23	Whitehaven Rd.	Accident Injury	Deputies responded to a report of a 2 car motor vehicle accident. 1 person was transported to a local hospital with seemingly non life threatening injuries.
8/23	Spicer Creek Run	Suspicious Incident	Complainant states that she heard noises coming from a residence on Spicer Creek Run. Deputies were able to contact the homeowner who was completing repairs on the home.
8/23	Staley Rd.	Animal Complaint	Complainant states that 3 horses were running around her property. Deputies located the owner of the horses and advised him.
8/23	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
8/23	Ransom Rd.	Criminal Mischief	Complainant states that sometime during the day, an unknown person(s) broke a window on her vehicle.
8/23	Grand Island Blvd.	Larceny	An employee at Tai Pei Chinese restaurant stated an unknown customer stole her cell phone sometime during business hours. Investigation Ongoing.
8/24	East River Rd.	Residential Burglary	Complainant states sometime in recent days, an unknown person(s) broke into her residence by forcing open a window. At the time of the report, the complainant could not identify anything missing. Investigation Ongoing.
8/24	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
8/24	Alvin Rd.	Suspicious Person	Complainant states that 2 suspicious males were looking into vehicles at Fucillo Chevrolet while the business was closed. Deputies located the subjects who stated they were looking to buy a vehicle. The subjects were advised to come back during business hours.
8/24	Grand Island Blvd.	Suspicious Person	Complainant states that a male subject was sleeping on a picnic table near the Grand Island Plaza. Deputies located the male and were able to contact a cab to drive him home.
3/9/2012	East River Rd.	Burglary	Following a Burglary investigation by the Erie County Sheriffs Detective Bureau, 30 y/o Justin Slaiman was arrested and charged with Criminal Possession of Stolen

			Property 4 th Degree (Class E Felony) in connection with the incident. Slaiman was transported to the Erie County Holding Center pending his arraignment in the Town of Grand Island Court. An investigation into the Burglary is still ongoing.
