WHEREAS, the Town staff and consultants thereafter determined after the receipt of all comments and responses that the DSEIS was complete, based on the final written scope and the standards contained in the SEQRA regulations and adequate with respect to its scope and content for the purpose of commencing public review; and

WHEREAS, the Town Board has made no decisions on any aspect of the Project, and will not do so until after a public comment period including a public hearing, and the preparation and acceptance of Final Supplemental Environmental Impact Statement addressing all comments at the public hearing and received written comments, and which will consist of: the DSEIS, including any necessary revisions and supplements; copies or a summary of the substantive comments received and their sources; and the Town's response to the comments.
