At 6:40 p.m. on Wednesday, January 4th, Grand Island Fire Company rescue personnel responded to a motor vehicle collision with a building incident at 11 Regency Drive. Homeowner Phyllis Lock was sitting in the kitchen with her older sister when they heard what sounded like an explosion. The ladies then heard pounding on the door as the driver alerted them to the problem and helped them get to the neighbors, where the GIFC was contacted.

Fire Chief Chris Soluri confirmed that 54 year-old David Adams of Niagara Falls had lost control of his vehicle which veered off Stony Point Road and traveled about 60 feet before striking the Regency Drive home. The force of the impact dislodged an exterior gas meter while the vehicle itself crashed through a wall and ended up about three feet into the basement. The driver claimed no injuries when evaluated by GIFC medics. The gas meter was shut down and National Fuel was notified while the house was ventilated to remove hazardous fumes.

\$30,000 in Damage at Garage Fire - January 2017

At 4:30 p.m. on Saturday, January 7th, Grand Island firefighters responded to a structure fire at the Bedell Road residence of David Butcher. An alert neighbor noticed visible smoke and flames coming from a two car unattached garage at the Butcher home and immediately contacted the homeowner and the Grand Island Fire Company.

Deputy Fire Chief Mark Sadkowski reported a working fire as Engines #2,#4,#5, LT 6 and fire suppression crews arrived on location. Despite two frozen hydrants west of the involved building, the fire was knocked down and under control at 4:51 p.m. Firefighters used the direct water supply from engines on scene. Total damage was estimated at \$20,000 to the structure and \$10,000 to the contents. The 76 year-old homeowner was treated for smoke inhalation but declined hospitalization.

Coyote Coexistence in Grand Island - January 2017

Coyote sightings are not uncommon in Grand Island and at this time of year when foliage is bare, you may easily see coyotes more often. Coyotes are afraid of people and typically avoid interactions, but with the timing of their natural life cycle, seasonal changes, and changes in their habitats and surroundings, these factors may bring coyotes into sight and contact more often.

January and February is the mating period for coyotes. Coyotes mate for life and control reproduction rates and litter sizes when the pack structure remains stable. They are attentive parents, teaching their children natural boundaries and food sources, which is why disruption of coyote pack structure can change their biology and behaviors. During spring, coyotes will select their dens and prepare for having pups. Once the pups are born in March and April, the parents take care of them over the spring and summer and work to protect and educate them.

Stacey Watt - January 2017



Stacey Watt created the Grand Island Challenge in January 2017. It was to complete a room with care for the John R. Oishei Children's Hospital. Residents of Grand Island were invited to make a donation and boy did they. Grand Island was the only community in the Western New York area to do so. On Thursday, August 31st, representatives of Oishei Children's Hospital came to Grand Island High School to accept a check for \$25,225. The Grand Island School District raised over \$10,000 through a read-a-thon.

Kinney noted that special use permits will still be needed for all of the commercial enterprises and there are minimum acreage restrictions. The law was approved 4-0. Fire suppression crews from Engines #3,4,5 and LT 6 gained building entry at 1:02 p.m. and determined that there was a major fire concentrated in three labs on the second floor.

Scenic Woods Project Begins - March 2017

On March 23, 2017, Supervisor Nathan McMurray announced the Scenic Woods project was being started on Friday, March 24th, with Phase One. This project will eventually provide walking trails over 229 acres, in the area of Ransom Road & East River Road.

This all began in 2000, after years of research by the Environmental Conservation Commission; Grand Island acquired 209 acres in the area of Ransom Road and East River Road with mitigation funds from the Army Corp of Engineers and the Fish & Wildlife Service.

The WNY Land Conservancy would like to purchase 140 acres of the 157-acre Assumption Cemetery located at 2950 Whitehaven Road, to create a forest preserve. The property is owned by the Catholic Cemeteries of the Diocese of Buffalo. The purchasing agency is requesting funds from the Niagara River Greenway Commission, which will consider the proposal at a Tuesday, May 16, 2017 meeting. The Greenway Commission and Gallogly Family Foundation provided \$700,000 to purchase the acreage in September '17.

Boater Cooperation Needed - April 2017



Boater Cooperation Needed to Help Protect Bald Eagles and Habitat Improvements at Strawberry Island As boating season approaches, New York State Department of Environmental Conservation (DEC) and New York State Office of Parks, Recreation and Historic Preservation (OPRHP) remind boaters to observe the signage, buoys, and various motorized boating restrictions in place around Strawberry Island in the Niagara River. The restrictions are part of an ongoing, multi-agency effort to protect critical Bald Eagle nesting habitat and to preserve recently installed habitat improvement projects at the island.

Mark Thomas Responds - July 2017

In response to the letter sent by Councilman Mike Madigan to Mark Thomas of NYS Parks, regarding the closing of the West River Parkway. Mr. Thomas replied in an email:

Town Councilman Madigan and Supervisor McMurray,

I am in receipt of the attached letter from July 19, 2017 sent to me by Councilman Madigan. My response is as follows:

Councilman, you speak of a Town Board vote on "01-August 2017" rejecting our plans as shared with you. I imagine that is referencing your vote taken in 2016.

The prime purpose of Councilman Madigan's letter appears to ask us to clarify the status of our project on West River Parkway. I can tell you that we in no way are cancelling this project and are continuing to pursue it as we have publicly presented at a Town Board meeting and I confirmed in my email of May 24, 2017. It remains our plan to bid the project this Fall with construction commencing in the Spring of 2018.

Our public process regarding this project is complete. Throughout the project planning we have exceeded the required public input sessions and continue to take into account the community concerns expressed as we advance final design. Safety concerns are being addressed in the final design work being conducted by C & S Engineers.

Councilman, you continue to reference a "legal contract" as the basis of much of your criticism of our actions. No such signed document exists of which we are aware.

As we progress with final design our consulting firm as well as park staff will likely be in communication with the Town as matters of our mutual concern may arise.

Daytime Burglary Thwarted - July 2017

Daytime Burglary Thwarted by Deputies and GI Police- Concerned Citizen Calls in the Suspicious Activity Buffalo, NY - Erie County Sheriff Timothy B. Howard reports Deputies, a Detective, and a Grand Island Police Officer responded to a concerned citizen's call about a suspicious vehicle with two males along Harvey Road in Grand Island Wednesday afternoon, July 27th, around 1:30. An individual observed the males park their vehicle near the house and walk around the back of a Harvey Road dwelling prompting a call to police. Shortly after the call, Deputy Was and Grand Island Police Officer Niemann arrived on location and observed signs the dwelling was entered and heard someone in the house.

Deputy Ginnane and Detective O'Hara arrived, and one of the subjects attempted to flee. Officer Niemann made contact with the subject outside the dwelling, and the subject tried to flee around the house but was met by Deputy Ginnane near the front of the structure. The subject ran back into the dwelling and secured the door behind him. Deputy Ginnane breached the front door and called for the suspect to surrender, but he attempted to exit the house by leaping from a window and landing face-first into a row of cacti plants. Deputy Was and Detective O'Hara quickly apprehended the suspect and placed Matthew Vaughn, 27 of Niagara Falls, in custody. When Vaughn was captured, he was wearing a black ski mask and knit gloves.

Deputies Ginnane and Was along with Officer Niemann began searching the house for the second subject. The subject was located hiding in the basement and surrendered to officers. When taken into custody, Jeremy Cyphers - 23 of Niagara Falls was wearing a dust mask and knit gloves. Defendant Vaughn is charged with felony counts of burglary and grand larceny, as well as misdemeanor counts of resisting arrest and criminal mischief. A pillow case containing stolen belonging was recovered and taken for processing. The defendants were arraigned in Grand Island Court Wednesday, and Cyphers is being held at the Erie County Holding Center on \$25,000.00 cash bail or \$50,000.00 bond. Vaughn is held on \$75,000.00 cash bail and \$100,000.00 bond.

In a 5-1 vote, the Grand Island School Board voted against one full-time SRO in favor of two part-time Grand Island Police Department officers at the Monday, December 11th meeting. School Board President Lisa Pyc abstained from voting and Vice President Donna Tomkins voted against the resolution. At the December 4th Town Board meeting, the Grand Island Town Board agreed to support the plan for two part-time Grand Island Police School Resource Officers rather than a single full-time School Resource Officer that would not be a Grand Island Police Officer.

Town Board Votes to Accept Bids for Community Center - December 2017

In a 3-2 vote (McMurray & Kinney against), the Grand island Town Board voted to accept bids for a Community Center to include a gym and meeting rooms. The dissenters thought a better plan was to get an engineering firm to draw up plans for bidders.
