President's Message:

The WRHOA has been very active in the past few years and we have tried to share information through email blasts sent to all residents for whom we have an address. Now that things have settled down a bit, the Board has agreed that future correspondence will be sent only to paid members unless there is an emergency that we feel needs the attention of all West River residents. If you are asked about this by a neighbor, please encourage them to contact Colleen Martin to register as a member and pay their fees so they are kept in the loop. In the meantime, if you are a paid member, you will receive the newsletter, email blasts, and invitations to all neighborhood WRHOA events.

In a continuing effort to work with the NYS Parks Department, we have met with the regional director, the local park manager, and the public relations officer several times. The grass cutting has happened as a result of our efforts and the recent support of the Town of Grand Island board members. Funding for the mowing has, however, meant that the clearing of brush, dead trees, and invasive species has been curtailed for much of this year. Future discussions will include the development of a plan where the residents of the West River can assist with the maintenance of the median and with the beautification of the area surrounding the path in front of our homes. We have invited Mark Mistretta to be our speaker at our annual meeting so everyone can hear about the landscape plan he wants to develop for the riverfront and the opportunity we have to become an organization that coordinates our efforts with the Parks Department so we can coexist and enjoy the benefits of our beautiful neighborhood. Please see the attached form so you can submit your questions. We want Mr. Mistretta to address our concerns in a thoughtful way and providing your questions in advance of the meeting will assist in that effort.

WRHOA would like to thank all those who contributed funds for the hiring of the attorney as we attempted to clarify the issue of the bike path and the closing of the parkway. We received the final reconciliation from the attorney this quarter. His report includes a discussion of the possible legal actions that might have been taken had we had the support of our local representatives in State government or that of our entire Town Board. He reviewed case law but determined that because of the absence of sufficient factual or legal basis for a claim, we would find it difficult to change the direction of the political powers in the Town and State and there was not sufficient financial support available to continue the action. He does feel that our efforts contributed to the delay of the project and a renewed interest on the part of the State Parks Department to recognize the

necessity of working with the residents along the pathway. According to the attorney's report, he not only was paid for a portion of his efforts, but he contributed many additional hours to the effort. Despite the expense, the WRHOA has maintained its financial stability and we have not incurred any debt as a result of our actions. Once again, we wish to send a BIG thank you to those who contributed to the effort.

The Board meets every other month and continues to conduct business throughout the months through email. If you have questions or concerns, please feel free to contact me at jjc1945@roadrunner.com. The passage of a new Master Plan for Grand Island will provide several opportunities for discussion about what people think the Island should look like in the future. The West River is a major residential area and any plans for waterfront development, development of commercial or manufacturing areas near us, or increase in housing and loss of vegetation on the Island will impact us and the value of our homes. We need to be part of the planning for the future. We are in need of residents to represent our neighborhood at Town Board and Advisory Board meetings. Parkway Grass & Dock Permit updates; As you have been aware the Parkway grass cutting has been revisited in late spring. Grass cutting of the parkway and median will be 80% cut and 20% meadow. However, we are in hopes they will continue to keep cutting, at least to meet the 12 times before the year is over. 50 Dock permits were issued this summer. Whether or not all 50 were actually installed, they did allow 50! Dock permit holders had to work with and appease the State and other Gov't with dock regulation and compliance. We did not receive much bad feedback from dock permit holders, besides trying to obtain permission or access the trail with a vehicle to install their docks. We are in hopes they will permit vehicles at the end of the boating season, to remove docks efficiently and in timely manner.
